**Notice for Extended Stray Vacancy Round of Counselling for
UG (BAMS) PwBD category**

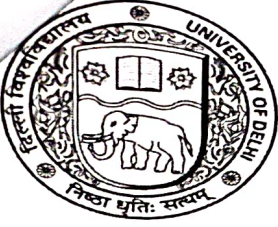
It is notified to all concerned that in pursuance to the letter No. 26-18/MARB/DL/2024(AY) dated 09.12.2024 of NCISM, Ministry of AYUSH regarding Grant of conditional permission to A& U Tibbia College and Hospital, with intake of 60 seats (75 seats including EWS) in UG(BAMS/BUMS) courses and granted remaining 37 seats (32 – DQ and 05 – AIQ) for admission to UG (BAMS) Course and NCISM/Examinations/StateDME/2024 dated 12.11.2024 of NCISM, Ministry of AYUSH regarding **Reduction of Minimum percentile criteria of NEET UG-2024** for the Academic Session 2024-25. It is pertinent to mention here that no candidate of PwBD category had applied earlier for admission to UG (BAMS) course. **A fresh registration for PwBD candidates is being opened to fill the newly added seats (i.e. UR (PwBD) - 01 and OBC (PwBD) -01) by the NCISM on 09.12.2024.**

3	Publication of final lists as per merit of eligible candidates.	18.12.2024 (Wednesday)
4	Publication of Result for Extended Stray Vacancy Round of Counselling (PwBD Category) as per merit on the basis of AIR.	19.12.2024 (Thursday)
5	Downloading of 'Provisional allotment letter' and reporting at allotted Institute/College for admission by the candidate as per seat offered on the basis of merit (AIR) and availability of seat in the respective category in the Extended Stray Vacancy Round of Counselling	20.12.2024 (Friday)
