It is notified to all concerned that the 3<sup>rd</sup> Round of Counselling for admission to (MD/MS-Ayurveda & Unani) courses under 50% Delhi University Quota for the academic Year 2024-25 will be conducted as follows:

1.	Publication of final lists as per merit of eligible candidates in order of Merit (AIR).*	28.11.2024 (Thursday)
2.	Publication of Result for 3 <sup>rd</sup> Round of Counselling (Category wise) as per merit on the basis of AIR.	29.11.2024 (Friday)
3.	Downloading of 'Provisional allotment letter' and reporting at allotted Institute/College for admission by the candidate as per seat offered on the basis of merit (AIR) and availability of seat in the respective category in the 3 <sup>rd</sup> Round of Counselling.**	30.11.2024 (Saturday) to 02.12.2024 (Monday)

The selected candidates, as per the result published on the Faculty Website, are required to login on admission portal of the Faculty to download the "Provisional Allotment Letter" and to report to the respective college to complete the admission formalities as per the laid down procedure on the following link:

- 4. Download the Provisional Allotment Letter.
  - \*\*After downloading the Provisional Allotment Letter, the candidates are required to report at the allotted Institute/College for admission by the Candidate offered seat in the 3rd Round of Counselling.

#### Note:

- 1. The candidates are advised to report at the respective college for admission as per the merit list uploaded on the faculty website as per schedule and by the stipulated time positively. The admission will be done on the basis of the merit of the candidates and verification of the original documents at the time of admission. Further, the candidates who does not report at the respective college within stipulated date and time will cease his/her claim for admission. No further request in this regard shall be entertained in any case.
- 2.
