**Revised Notice for Special Round of Counselling**

It is notified to all concerned that in pursuance to the letter No. NCISM/Examinations/StateDME/2024 dated 12.11.2024 of NCISM, Ministry of AYUSH regarding Reduction of Minimum percentile criteria of NEET UG-2024 for admission in Undergraduate (UG) Course of ASU for the A.Y 2024-25, the Joint Admission Committee (JAC) in its meeting held on 22.11.2024 has considered that there are 5 seats (3-SC, 2-ST) remain vacant in UG (BUMS) Course due to non-availability of eligible candidates as per the earlier eligible criteria. Accordingly, the JAC decided that as per the reduction by Fifteen percentile for admission in UG Courses of ASU for the A.Y. 2024-25 **fresh registration may be allowed to the candidates of SC & ST category to utilize the vacant 5 seats (3-SC, 2-ST) under 85% Delhi Quota**, as a special case. The tentative schedule of the Special Round for admission to UG (BUMS) is as follows:

1	Online Fresh registration for 85% Delhi Quota	22.11.2024 (Friday) to 26.11.2024 (Tuesday)
2	Uploading of list of fresh registered applicants.	28.11.2024 (Thursday)
3	Publication of final lists as per merit of eligible candidates.	30.11.2024 (Saturday)
4	Publication of Result for Special Round of Counselling (Category wise) as per merit on the basis of AIR.	03.12.2024 (Tuesday)
5	Downloading of 'Provisional allotment letter' and reporting at allotted Institute/College for admission by the candidate as per seat offered on the basis of merit (AIR) and availability of seat in the respective category in the Special Round of Counselling	04.12.2024 (Wednesday) to 07.12.2024 (Saturday)

- The above schedule is tentative in nature and in case of any change, the same will be notified.
- It is also informed to all concerned that the Special Round of Counselling is being conducted to fill the vacant seats of the SC/ST category only. There is no seat vacant of other categories under 85% Delhi Quota. Therefore, the candidates of other categories are not required to register themselves. Please note that no refund will be allowed against any wrong registration by the candidates of the other categories.
