## **M O S T U R G E N T N O T I F I C A T I O N**

It is notified that the Hon'ble Supreme Court of India in the matter of WP (C) no. 197 of 2011 (Vivek Dudeja & Ors. Vs Union of India & Ors.) dated 13.05.2011 has passed the following Orders:

- (i) that the 2<sup>nd</sup> round of Counselling under 50% All India Quota has been extended upto 19/06/2011 to be conducted by DGHS at Delhi.
- (ii) that the candidates have been permitted to join the allotted Course/Institution upto **24/06/2011**.
- (iii) that the vacant position for PG Degree/Diploma Courses under 50% All India Quota may be deemed to be surrendered to the State on **25/06/2011**.
- (iv) the final deadline has been fixed for **30/06/2011**.

The Post-Graduate Admission Committee of the Faculty of Medical Sciences, University of Delhi at its meeting held on 27/05/2011 has decided as under:-

- (i) that the 3<sup>rd</sup> Counselling for allotment of vacant seats under 50% D.U. Quota/surrendered seats of 50% All India Quota will be conducted on **29/06/2011** at **9:00 A.M.** in the **Lecture Hall – II, 2<sup>nd</sup> Floor, V.P. Chest Institute Bldg., University of Delhi, Delhi-110007**.
- (ii) that the students under **50% Delhi University quota** who have already taken admission in the 1<sup>st</sup> & 2<sup>nd</sup> Round of counselling may surrender their PG seats latest by **28<sup>th</sup> June, 2011 till 02:00 PM** to the Deputy Registrar (FMSc) under the provision of the clause 9.7 of the Bulletin of Information (PGMET – 2011) to become eligible to attend the 3<sup>rd</sup> counselling. The candidates who are already in waiting list after the 2<sup>nd</sup> Counselling held on 30/05/2011 need not apply as name of the eligible candidates already exist in the waiting list.

The students are advised to use the prescribed proforma to surrender / resign the seat. The proforma may be downloaded from the faculty website [www.fmsc.ac.in](http://www.fmsc.ac.in) and the same may be submitted to the Deputy Registrar, Faculty of Medical Sciences, 6<sup>th</sup> Floor, VPCI Building, University of Delhi, Delhi – 110007.

- (iii) **that the students who have taken admission in any PG courses anywhere in India and not surrendered the PG seat shall not be eligible to attend the counselling.**
- (iv) that the students who take admission after 31.05.2011 i.e. after close of admission will either appear in Supplementary examination (D.U. Examination) to be held during the period 2013/2014 or the permissible leave (30 days) be proportionately adjusted in the 1<sup>st</sup> year itself against shortage of Training. However, a weeks time i.e. six working days may be condoned.
- (v) that the students who have been admitted in PG Degree/Diploma seats **under 50% All India Quota** may surrender / resign their PG seats **latest by 27.06.2011 till 05:30 PM** to the Deputy Registrar (FMSc). It is clarified that the students admitted under 50% All India Quota are not eligible to attend the DPG counselling.

The students are advised to use the prescribed proforma to surrender / resign the seat. The proforma may be downloaded from the faculty website [www.fmsc.ac.in](http://www.fmsc.ac.in) and the same may be submitted to the Deputy Registrar, Faculty of Medical Sciences, 6<sup>th</sup> Floor, VPCI Building, University of Delhi, Delhi – 110007.
