(3) Reporting Time/Documents:-

The concerned candidates are required to report at 09.00 A.M. in the **Conference Centre, Opposite Department of Botany, University of Delhi, Delhi-110007** on specified dates given above. They should bring the following documents in Original alongwith one set of photocopies of the documents. The original certificates will be returned to the candidates after verification and one set of copies of original documents will be retained by the Faculty:-

1. AIPMT-2012 Final Examination Admit Card (downloaded).
2. AIPMT-2012 final result (Score card downloaded).
3. Matriculation or equivalent certificate showing date of birth.
4. Certificate of having passed 12th Class Examination along with a statement of marks.
5. Certificate from the Principal of the School on prescribed proforma (**Page No. 4 of Application Form**) stating that (i) the school is situated within National Capital Territory of Delhi, (ii) the school is recognized by the CBSE/Council for the Indian School Certificate/Jamia Milia Islamia, (iii) the school is conducting regular classes, (iv) the applicant has attended regular classes in the school for class 11th & 12th.
6. Recent Character Certificate from Principal of the school last attended or from any Gazetted officer.
7. Scheduled Caste/ Scheduled Tribe certificate as described in **clause 2.2.2**, if applicable.
8. Father's SC/ST Certificate.
9. Physically Handicapped certificate as described in **clause 2.2.4**, if applicable.
10. Entitlement Certificate for CWWAPP category as described in **clause 2.2.3**, if applicable.
11. OBC Certificate as described in **clause 2.2.5**, if applicable.
12. Non-creamy layer certificate and OBC caste certificate as per the Central list for OBC's.
13. Two pass port size photograph.

(4) Assignment letter/joining the allotted course & college:-

- (a) The assignment letter will be issued to the allotted candidates after the counselling on the same day of the counselling.
- (b) The candidates should report to the respective colleges within 03 days from the date of allotment and should complete the admission process in the college.
- (c) The candidate should deposit all the originals certificates (details given above) with the concerned authorities of the college.

(5) 2nd Counselling:-

The Medical Courses Admission Committee at its meeting held on 16.07.2012 noted that the Medical Council of India vide notice dated 10.07.2012 referring to the Hon'ble Supreme Court order dated 08.05.2012 in the matter of Priya Gupta Vs. State of Chhatishgarh & Ors Civil Appeal No. 4319 of 2012 and arising out of SLP (C) No. 29306 of 2011 and resolved that the resultant vacancy (MBBS/BDS), if any, after the 1st Counselling shall be uploaded in the Faculty web-site i.e. www.fmssc.ac.in and the same will be filled-up strictly according to the merit by holding 2nd Counselling on 15th September, 2012.

In keeping with the Hon'ble Supreme Court order dated 08.05.2012, the vacancy (MBBS/BDS) arising thereafter, if any, shall be filled-up strictly according to the merit from the waitlisted candidates and the admission will close on 30th September, 2012.
