- (a) The four (04) vacant MBBS seats of MAMC fallen vacant after 1<sup>st</sup> Counselling have been given to OBC category in the light of the order of the Hon'ble High Court in the matter of Ashhar Musharib Firdausi Vs. University of Delhi & Ors. CWP No. 4378/2010 dated 11<sup>th</sup> August, 2010 and the decision of the Competent Authority of the University dated 05.09.2011 (Dairy no. DR-Acd-TR 722/05.09.2011).  
  
(b) (\*\*) As on date there is a shortage of 04 (four) OBC seats in MAMC. The Medical Council of India vide letter dated 28.07.2011 has not allowed to increase MBBS seat more than 250 seats.
- (#) In UCMS 1 seat of ST category, 02 seats of OBC category and 06 seats of General category have fallen vacant after 1<sup>st</sup> Counselling.
