# General Terms & Conditions Stray Round of Counselling Admission to BAMS/BUMS/BHMS for the Academic Session 2020-2021 for 85% Delhi Quota Seats.

1. Only NEET 2020 qualified candidates are eligible to participate in the counselling.

2. The general eligibility criteria of admission shall be as per Bulletin of Information (BOI) 2020 for BAMS/ BUMS/ BHMS available on the website of the Faculty.

3. The personal appearance of the candidates before the Admission Committee during the counselling along-with all original certificates as mentioned in the Bulletin of Information BOI is mandatory.

4. Any candidate who fails to deposit the original documents alongwith the fee during the

given time frame, will forfeit his/her claim for admission.

- 5. Candidate must attain age of 17 years as or on before 31.12.2020 and further the Ministry of AYUSH vide letter no. L-11011/2/2020/E-P-(1)-Part -2 dated 06.01.2021 directed to all AYUSH colleges to consider the candidates who are 25 years of age and above shall be entitled to apply and appear in the NEET UG 2020 examination subject to the outcome of the aforesaid pending petitions before the Hon'ble Supreme Court.
- If any discrepancy/false statement is found in the documents of the candidate at any stage, his/her admission shall be cancelled and legal action shall be taken as per University rules.
