(50% Delhi University Quota)

It is notified to all concerned that the admission process of Ayurveda Vachaspati/ Ayurveda Dhanvantari (MD/MS-Ayurveda)/ Mahire- Tib/ Mahire Jarahat (MD/MS- Unani) courses in the Faculty of Ayurveda & Unani Medicines and MD-Homoeopathy in the Faculty of Homoeopathic Medicines University of Delhi, under 50% Delhi University Quota, for the session 2022, will be made on the basis of the merit/Rank of AIAPGET- 2022.

1. Only, eligible candidates shall register online on website www.fmsc.ac.in Faculty of Ayurveda & Unani Medicines / Faculty of Homoeopathic Medicines.
2. The Candidates are advised to visit website www.fmsc.ac.in regularly for any updates.
3. Those candidates who have completed their compulsory internship training on or before 31-12-2022 are only eligible to apply.

A) *Discrepancy, if any may be brought to the notice of the Assistant Registrar (Faculty of Ayurveda & Unani Medicines and Faculty of Homoeopathy Medicine) by email only, at ar@fmsc.du.ac.in lasted by 29-1-2023 till 3.00 p.m. beyond which no request for any change will be entertained.

B) In case seats remain vacant after 1st round of counselling than 2nd round of counselling will be held and date will be notified later on.

C) The above schedule is tentative in nature and in case of any change, the same will be notified.

D) All registered candidates are compulsorily required to fill online choice filling afresh during aforementioned prescribed schedule. Choice filling done by the candidate at the time of registration are null and void and will not be considered for allotment. Seat allotment will only be done to those candidates who will fill the online choice filling. In case of non-filling of choice, seat will not be allotted and the candidate shall be solely responsible.

E) The candidate is required to produce/submit all original documents along with two sets of self attested photo copies at the time of reporting compulsorily as mentioned in Bulletin of Information of PG (MD/MS- Ayurveda, Unani and MD-Homoeopathy for the year -2022-23.
