NOTICE

Sub.: Counselling for allotment of MBBS/BDS seats to OBC category/SC category and Open Merit list candidates for the session 2010-2011, (DUMET-2010).

It is informed to all concerned that in pursuance to the order of the Hon'ble High Court dated 21.09.2010, WP (C) no. 4378/2010, LPA 657/2010, in the matter of Ashhar Musharib Firdausi vs. University of Delhi & Ors., the Board of Governors (Medical Council of India) vide letter No. 34(41)/2010-Med./29841 dated 21.09.2010 has approved for enhancement of MBBS seats in Maulana Azad Medical College from 180 to 200 in order to implement OBC reservation under Central Education Institution Act, 2006.

It has been decided that the MBBS/BDS seats be filled up as per norms of reservation **by conducting counselling strictly according to merit on Saturday, the 25th September, 2010 at 09:00 A.M. in the Committee Room, Faculty of Medical Sciences, 7th Floor, V.P. Chest Institute Building, University of Delhi, Delhi-110007.**

The concerned candidates may appear before the Medical Courses Admission Committee on the above stipulated date, time and venue as under:-

1. **OBC category** - Rank 01 to 120.
2. **Open Merit List** - Rank-254, 255, 259, 260, 263, 264, 265, 267, 268, 269, 271, 273, 274 & 275 for allotment of MBBS seat in case vacancy arises.

(Rank 256, 257, 258, 261 & 262 have already been admitted in LHMC, Rank 266 & 272 were absent in the 1st counselling, Rank 270 is a SC female candidate from outside Delhi)

3. **SC category** - Rank-92, 96, 97, 98, 103, 109 for re-allotment of MBBS seat in MAMC if vacancy arises and Rank-157, 192, 217, 241, 243, 250, 256, 262, 263, 268 for allotment of MBBS seat if vacancy arises.

There is no vacancy in Lady Hardinge Medical College hence the female candidates from outside Delhi have not been included.

Note:-

- (1) The candidate of Open Merit list already informed vide letter No. FMSc./UG/2010/10525 dated 18.09.2010 for allotment of BDS seats may appear before the Committee on 25.09.2010 at 09:00 A.M.
- (2) The allotment of MBBS seat is subject to the final outcome in the writ petition.
- (3) In case of any discrepancy the same may be brought to the notice of the Dean, Faculty of Medical Sciences, University of Delhi, Delhi-110007.
