NOTIFICATION

It is notified that the Hon'ble Supreme Court of India in the matter of Naval Asija & Ors. Vs. Union of India & Ors. WP (C) No. 189/2010 has passed the following Orders:

- (i) that the 2nd round of Counselling under 50% All India Quota has been extended upto 12/06/2010 to be conducted by DGHS at Delhi.
- (ii) that the candidates have been permitted to join the allotted Course/Institution upto 20/06/2010.
- (iii) that the vacant position for PG Degree/Diploma Course under 50% All India Quota may be deemed to be surrendered to the State on 21/06/2010.
- (iv) the final deadline has been fixed for 30/06/2010.

The Post-Graduate Admission Committee of the Faculty of Medical Sciences, University of Delhi at its meeting held on 14/06/2010 has decided that the 3rd Counselling for allotment of vacant seats under 50% D.U. Quota/surrendered seats of 50% All India Quota may be conducted on 29/06/2010 at 9:00 A.M. onwards in the Committee Room, Faculty of Medical Sciences, 7th Floor, V.P. Chest Institute Bldg., University of Delhi, Delhi-110007, only if, some of the PG Degree/Diploma seats are surrendered under 50% All India Quota to the State.

The Post-Graduate Admission Committee has further decided that:

- (i) the Faculty may conduct 3rd Counselling on 29/06/2010 at 9:00 A.M. onwards for allotment of PG Degree/Diploma seats surrendered under 50% All India Quota if any.
- (ii) the students who may have taken admission after 31/05/2010 i.e. after close of admission will either appear in Supplementary Examination (D.U. Examinations) to be held during the period 2012/2013 or the permissible leave (30 days) be proportionately adjusted against shortage of training.
- (iii) The delay in admission upto a week's time i.e. six (06) working days be condoned and beyond this week's time either the student concerned may appear in Supplementary Examination or permissible leave may be proportionately deducted.

The students who have been allotted and admitted in PG Degree/Diploma seats under 50% D.U. Quota may visit the website and in case they desire to attend the 3rd Counselling scheduled to be held on 29/06/2010 may surrender the allotted seat to become eligible to attend the 3rd Counselling. The candidates who are already in waiting list after the 2rd Counselling held on 30/05/2010 need not apply as name of the eligible candidates already exist in the waiting list.
