NOTIFICATION

It is notified for all concern that the 2nd DPG counselling for allotment of (Degree/Diploma) seats under 50% Delhi University Quota has been scheduled for 13th August, 2013 (Tuesday) and 14th August, 2013 (Wednesday) at 09:00 am onwards in the Conference Center, opposite department of botany, University of Delhi, Delhi – 110007 in pursuance to the order of the Hon'ble Supreme Court of India dated 05.08.2013 in the matter of Manish Nigam & ANR Vs Smit Rajput & ORS SLP (civil) 24528/2013.

The concerned candidates are requested to report at 09:00 AM sharp in the Conference Center, opposite department of botany, University of Delhi, Delhi – 110007. The following information may kindly be noted:-

- 1. The candidates who desire to surrender / relinquish the allotted PG seat of 1st DPG counselling may do so on or before 10th August 2013 latest by 01:00 PM.
- 2. The vacancy position available and the merit list of waitlisted candidates for the 2nd DPG counselling will be uploaded in the Faculty website www.fmsc.ac.in on 12.08.2013 (Monday) latest by 10:00 AM.
- 3. Counselling on 13th August, 2013

The counselling shall be conducted as per procedure given in the Bulletin of Information-2013 viz Common Merit followed by ST, SC and OBC including PwD. The vacant seat if any, reserved for ST category will be converted to SC category and the same will be filled up by SC candidates strictly according to merit. Thereafter, the vacant seat if any, of SC category and OBC will be converted to Common merit (Clause 5.1 of BOI -2013) to be filled in the counselling to be held on 14.08.2013.

4. Counselling on 14th August, 2013

- **a.** Since the vacant seats if any, of SC category and OBC have been converted to Common merit on 13.08.2013, the converted seat / resultant seat if any, shall be filled up on 14th August, 2013 by **operating Common Merit List only.**
- b. The candidates who desire to surrender / relinquish the allotted PG seat on 13.08.2013 or in the 1st counselling may do so on or before 14th August 2013 latest by 11:00 AM.
- c. The available vacant seat and the waitlisted common merit list will be displayed by 01:00 PM on 14.08.2013.
- d. Thereafter, the counselling will be conducted at 02:00 PM onwards.

Note: - The candidates may surrender / relinquish their allotted seat to the Deputy Registrar, Faculty of Medical Sciences, University of Delhi, Delhi – 110007
