NOTIFICATION

In continuation of the notification dated 08th August, 2013 it is notified for all concerned that Post Graduate Admission Committee (PGAC) at its meeting held on 13.08.2013 considered and examined the representation of the students dated 12.08.2013, e-mail dated 08.08.2013 received from M.J.S. Rupal, University counsel intimating the interim order of the Hon'ble Supreme Court in the matter of Manish Nigam and Ors (SLP) , order of the Hon'ble Supreme court in the matter of Dr. Fraz Naseem & Ors vs Union of India and Ors WP(c) no. 433 of 2013. The PGAC after examining / discussion decided as follows:-

1. There shall be only one counselling as already scheduled for 13.08.2013.
2. The scheduled counselling for 14.08.2013 be cancelled
3. The schedule after the surrender of All India Quota vacant seats shall be as follows:-

a. 21st August, 2013

The vacant seats of All India Quota will be uploaded in the faculty website by 09:00 PM after applying 200 point roster.

b. 22nd August, 2013

- (i) The candidates who desire to surrender / relinquish the allotted PG seat of 1st /2nd DPG counselling may do so **latest by 03:00 PM.**
- (ii) vacancy position available and the merit list of waitlisted candidates for the extended 2nd Round of DPG counselling will be uploaded in the Faculty website www.fmssc.ac.in on 22.08.2013 latest by 09:00 PM.

c. 23rd August, 2013

- (i) **The counselling shall be conducted at 09:00 AM onwards** as per procedure given in the Bulletin of Information-2013 viz Common Merit followed by ST, SC and OBC including PwD. The vacant seat if any, reserved for ST category will be converted to SC category and the same will be filled up by SC candidates strictly according to merit. Thereafter, the vacant seat if any, of SC category and OBC will be converted to Common merit (Clause 5.1 of BOI -2013) to be filled in the **counselling to be held on 26.08.2013 (Monday).**
- (ii) The vacancy position will be uploaded by 09:00 PM

d. 24th August, 2013

- i. Since the vacant seats if any, of SC category and OBC have been converted to Common merit on 23.8.2013, the converted seat / resultant seat if any, shall be filled up by **operating Common Merit List only.**
- ii. The candidates who desire to surrender / relinquish the allotted PG seat on 23.08.2013 or in the 1st /2nd counselling may do so on or before 24th August 2013 latest by 01:00 PM.
- iii. The available vacant seat and the waitlisted common merit list will be displayed by 09:00 PM on 24.08.2013.

e. 26th August, 2013 (Monday)

- i. **The counselling shall be conducted at 09:00 AM onwards** as per procedure given in the Bulletin of Information-2013 only by operating Common Merit.
- ii. The candidates are required to complete the admission process and to join the allotted seat/Institution on 26.08.2013.
- iii. The candidates are advised to download the prescribed proforma of the surety bond and get it ready in all respect except the discipline (PG seat) and the Institution, which can be filled up once the seat and Institution is allotted.
- iv. The admission will close on 26.08.2013 (Monday). No extension of time will be permitted to students beyond 26.08.2013 who join the allotted seat and Institution.

Note: - The venue of the extended 2nd round of counselling will be notified in due course of time.
