This schedule is being notified for admission on the seats in “50% University of Delhi Quota Seats in MD/MS/Diploma/MDS and seats’ and in MD(Community Health Administration) in University of Delhi.

The procedure for ‘Registration for Counselling and Verification of Documents’ and “1st Round of Counselling” for the above said programmes is given below :

50% DU Quota Seats in MD/MS/Diploma Seats

A. “Registration for Counselling and Verification of Documents”

- (a) The candidates who have registered themselves online in University of Delhi under 50% DU Quota are eligible to attend the Counselling and Verification of documents as per the schedule given below.
- (b) All the candidates who have passed MBBS from the affiliated medical colleges of University of Delhi and must have completed one year compulsory rotatory internship by the stipulated date as mentioned in the Bulletin of Information -2017 of University of Delhi and also qualified NEET PG 2017 are eligible for ‘Registration for Counselling and Verification of Documents’ in the manner as mentioned as prescribed herein.
- (c) All the NEET qualified candidates will present themselves for ‘Registration for Counselling and Verification of Documents’, in person, on the scheduled date and time, as given below
- (d) This ‘Registration for Counselling and Verification of Documents’ will be valid for both 1st and 2nd round of counselling is given below. **In no case, a candidate will be allowed to participate in the 1st and 2nd round of counselling unless he/she has registered for participation in the counselling.** IT IS MANDATORY FOR ALL THE QUALIFIED CANDIDATES TO GET THEMSELVES REGISTERED FOR PARTICIPATING IN 1ST and 2ND ROUND OF COUNSELLING.

I. The students admitted during 1st counselling are required to report for medical examination immediately in the allotted college.

J. Fee to be paid at the time of Counselling

A candidate, who is allotted a seat, will be required to pay **Rs.15,600/- (1st year Annual University Fee) and Rs.1,000/- (NON-REFUNDABLE Counselling Participation Fee) on the spot, at the time of counselling.** The fee will have to be paid in the form of **TWO SEPARATE DEMAND DRAFTS in favour of "Registrar, Guru Gobind Singh Indraprastha University" payable at Delhi.** Balance fee, if any shall be paid, directly in the allotted college after admission.

- (x) Persons with Disability (PwD) Certificate, if applicable.
- (xi) Surety Bond of Rs. 5.00 lacs duly filled in and signed by two sureties.
- (xii) The in-service candidates shall submit a No Objection Certificate (NOC) from their employer to the effect that they have no objection and the candidate will be relieved/ granted study leave for pursuing the course.
- (xiii) Three Year Experience Certificate – for MD Community Health Administration.
- (xiv) Photograph – 4 nos.

L. Withdrawal of admission. The candidate after getting admission in first round of counselling will be allowed to withdraw the admission upto 5.00 PM on **9th May 2017**. All the requests for withdrawal of admission in the prescribed format are to be submitted in the Faculty of Medical Sciences, 6th Floor, VPCI Building, Patel Chest, Delhi-110 007.

M. Joining the Allotted College. The candidate who had secured admission during the 1st round of counselling but did not join the allotted college by 22/04/2017 will be considered as a Vacant Seat. It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the programme they seek admission. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or untrue, the admission shall be cancelled and the fees will be forfeited.

All the admissions are provisional.
