The Scheme of All India Quota/ Deemed/ Central University/ ESIC Post Graduate Courses (MD/ MS/ Diploma/ MDS) Online Counseling (allotment process) has been revised for the year 2019. All Candidates are requested to go through the revised scheme carefully and understand before participating in online counseling (allotment process).

B. The Scheme is further explained in the following Frequently Asked Questions (FAQs)

*Facility for New Registration will be available for Round-1, beginning of Round-2 and mop-up round only, on dates as specified in Counseling Schedule. For eligibility of registration please read Frequently Answer Questions. There will be no fresh registration for Stray Vacancy Round.

**Joining at allotted Institution is necessary, if candidate who has been allotted a seat fails to join the allotted college/seat within stipulated time, before last date of joining (as per counseling schedule), the allotted seat will be cancelled.

Frequently Asked Questions (FAQs)

For

All India Quota/ Deemed/ Central Universities / ESIC Online Counseling for Post-graduate Medical/ Dental /Diploma Seats (MD/ MS/ Diploma/ MDS Courses) 2019

Q. No. 1: What is the process of online allotment?

Ans: ROUND-1

- a) **Main counseling Registration** which will include payment of Non-Refundable Registration fee and Refundable Tuition fee (to be refunded in the account from which payment has been made).
- b) Exercising of Choices and Locking of choices.
- c) Process of Seat Allotment Round-1
- d) Publication of result of Round-1
- e) Reporting at the allotted Medical/Dental College against 1 Round.

ROUND-2

(Candidates who registered for Round-1 and did not get any seat allotted need not register again.)

- f) Fresh New Registration for Round-2 for those candidates who
 - Have not registered in Round-1 (with full payment of fees).
 - Have Resigned / Not reported in Round-1 can log in again.
- g) Fresh Choice filling Round-2.
- h) Publication of result of Round-2.
- i) Reporting at the allotted Medical/Dental College against Round 2

End of AIQ Quota Round

MOP-UP ROUND

- j) Mop Up Round (Only for Deemed/ Central Universities & ESIC)
- ➤ Fresh Registration for Mop Up Round for candidates including those who registered in Round-1 & exited /who registered in Round-2 & exited with Forfeiture of fees. However, candidates who have already joined and taken admission in Round-2 of AIQ/ Deemed/ Central Universities will not be eligible to participate in Mop Up Round. (Those who registered but were not allotted a seat in Round-1 & Round-2 need not register again).
- > Fresh choice filling of Mop Up Round
- > Publication of result of Mop Up Round
- ➤ Reporting at the Allotted Medical/ Dental College after Mop Up Round
- List of ten times (of the registered candidates) of number of Stray vacancies to be sent to Deemed / Central Universities to be exhausted strictly in order of merit.

➤ Final Stray Vacancy Round to be conducted by Deemed/ Central Universities/ ESIC (There will be no Fresh Registration of Candidates in Final Stray Vacancy Round)

PLEASE NOTE THAT REGISTRATION FACILITY SHALL BE AVAILABLE AT THE BEGINING OF FIRST ROUND, SECOND ROUND & MOP UP ROUND OF DGHS ONLY ON NOTIFIED DATES. THEREAFTER, REGISTRATION FACILITY SHALL NOT BE AVAILABLE. UNDER NO CIRCUMSTANCES ANY REQUEST (FOR ANY REASON) FOR REGISTRATION, SHALL BE ENTERTAINED AFTER CLOSING OF REGISTRATION.

Q. No. 2: When will online allotment process for this year start?

Ans: Online allotment process will start as per counseling Schedule for PG online Counseling for this year.

Please See Schedule available on www.mcc.nic.in website.

Q. No. 3: Do I have to report to any counseling center for registration or choice filling?

Ans: No. Online registration and choice filling can be done from place of convenience (Including from home) using internet. Uninterrupted internet facility should be ensured.

Q. No. 4: Do I require any documents to get registered on-line?

Ans: You will be required to fill up some of the information that you have given (filled up) on your application form, and submitted to National Board Examinations (NBE), New Delhi and information available on admit cards of AIPGMEE/AIPGDEE.

IMPORTANT

"Please keep information that you have furnished (filled up) on application form and admit card, confidential, and do not share it with anybody as this information will be required to register for online allotment process and to submit choice. If somebody else uses that information, he/she can misuse your online registration and prevent you from taking part in online allotment process. Keep print out of application form ready for reference with you."

Q. No. 5: What information do I require for online registration?

Ans: Please note that you will be asked to fill some of the information (we are not showing it here for security reasons) that you have given in your application form, admit card of examination during online registration and provided by the examination conducting agency, (**NBE**)

therefore keep a copy of your application form and admit card ready for reference. These documents may be retained as they may be required till you complete your PG course.

IMPORTANT

"PLEASE NOTE THAT ON REGISTRATION WINDOW OF ONLINE ALLOTMENT PROCESS (on MCC), YOU HAVE TO FILL IN EXACTLY SAME SPELLING, NUMBERS ETC AS YOU HAVE FILLED IN YOUR APPLICATION FORM of NBE."

Q. No. 6: How do I get password for logging in?

Ans: During the process of online registration you will generate your own password. Candidates are advised to keep the password that they have created, confidential to them till the end of the counseling process. They can change the password after creating. Password is very important for participating in online allotment process. Sharing of password can result in its misuse by somebody else, leading to even exclusion of genuine candidate from online allotment process.

Q. No. 7: How much time will I be given to join the allotted course?

Ans: Candidates who are allotted seats will be required to join the allotted college/course within stipulated time from the date of allotment as mentioned in the counseling schedule. However, candidates are advised to join as early as possible and not to wait for last day of joining, due to different schedule of holiday/working hours in various Medical/Dental Colleges, also keeping in view that Medical/Dental colleges will have to furnish information about joining/non-joining online to Medical Counseling Committee. In some of the Colleges it takes 2 to 3 days' time for completion of admission formalities.

Q. No. 8: What documents are required at the time of Counseling?

Ans: Since it is online allotment (Online Counseling) process, no documents will be required for participating in online allotment process. However, you are required to carry Original Certificates / Documents at time of Reporting for Admission. Without Original Certificate/Documents candidates will not be allowed admission.

Q. No. 9: What documents are required at the time of joining in allotted Medical / Dental College?

Ans: Original documents required at the time of joining in allotted Medical/Dental College are as mentioned below:

- i. Admit Card issued by NBE
- ii. Result/Rank Letter issued by NBE
- iii. Mark Sheets of MBBS/BDS 1st, 2nd & 3rd Professional Examinations.
- iv. MBBS/BDS Degree Certificate/Provisional Certificate.
- v. Internship Completion Certificate/Certificate from the Head of Institution or College

that the candidate shall complete the Internship by 31st March, of the year of admission.

- vi. Permanent / provisional Registration Certificate issued by MCI or DCI/State Medical or Dental Counsel. Provision Registration Certificate is acceptable only in cases where candidate is undergoing internship land likely to complete the same on or before 31st March of year of admission.
- vii. High School/Higher Secondary Certificate/Birth Certificate as proof of date or birth.
- viii. Candidates allotted seat must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information Bulletin published by the National Board of Examinations (NBE) for AIPGMEE i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card).
- ix. The Candidate should also bring the following certificates, if applicable
 - a) SC/ST Certificate issued by the **competent authority** (in the format as specified in the prospectus) and should be in English or Hindi language. Sub caste should be clearly mentioned in the certificate.
 - b) OBC certificate issued by the **competent authority**. The sub-caste should tally with the Central List of OBC. The OBC candidates **should not belong to Creamy Layer**. The OBC certificate must be in the format as mentioned in the prospectus.
 - c) Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act,2016. No other PwD certificate, issued by any other Authorities/ Hospital will be entertained. The format of Certificate of Disability is attached as ANNEXURE-I.

Candidates without original certificates / documents shall not be allowed to take admission in allotted Medical / Dental College.

Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that "their original certificates are deposited with the Institute / College / University" shall not be allowed to take admission in allotted Medical/Dental College.

Q. No. 10: What are the various fees to be paid at the time of registration?

Ans: At the time of registration students must pay two kinds of fee

- a) Non-Refundable Registration fee
 - Rs. 1000/- For AIQ /Central University UR candidates, & Rs. 500/- For SC/ ST/ OBC/ PWD
 - Rs. 5000/- For Deemed University candidates
- b) Refundable Tuition Fee which will be refunded to candidates after joining the allotted college or if candidate did not get any seat during counseling to the same account of candidate from which payment had been made.
 - ➤ For AIQ / Central University UR candidates Rs. 25000/-
 - ➤ For SC/ST/OBC/PWD –Rs. 10,000/-
 - For Deemed -Rs 2.00.000/-
 - 1. Any UR candidate opting for Deemed University will have to pay Rs 5000/-Non-Refundable fee + Rs 2,00,000/- Refundable Tuition fee at the time of registration

2. Any SC candidate opting for AIQ only will pay registration fee of Rs 500/- + Rs. 10,000/- refundable tuition fee.

Q. No. 11: In case candidate must apply for both AIQ and for Deemed University should the candidate pay the fee for both?

Ans: No, in such case the candidate has to pay only the higher fee i.e. of Deemed University Rs. 5000/- and 2 Lakh Refundable Tuition fee.

Q. No. 12: Is this tuition fee refundable in all the cases?

Ans: No, this fee will be forfeited if the candidate who has been allotted a seat in the second Round or Mop Up Round of DGHS does not join the respective institution during the second round / Mop Up round of counseling conducted by DGHS/MCC. Also the Tuition fee will be forfeited in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting.

Q. No. 13: Where and when this fee will be refunded?

Ans: This fee will be refunded to the same account from which payment had been made. No requests for the change of Account shall be entertained afterwards. Candidates are also advised not to get their account closed till the time Refund has been made into the account from which payment was made. This fee will be refunded only after all the rounds of counseling are completed.

Q. No. 14: What are the instructions regarding OBC, SC, ST & PwD certificates?

Ans: Please read Information Bulletin for admission to post-graduate medical courses for admission to 50% of total PG seats on All-India basis carefully. The certificate requirements are mentioned in prospectus along with format. The certificate as mentioned in the prospectus only will be acceptable. Candidates are requested to read prospectus and instructions regarding Caste and Persons with Disability (PwD) Certificate carefully. In case the candidate fails to produce proper Caste (and PwD, if applicable) certificate at allotted Medical/Dental College then he/she will not be permitted to join the allotted Medical / Dental College and his/her category will be changed, if otherwise eligible.

Further the reservation of seats under PwD Category have been increased from 3% to 5% in AIQ and the 21 Benchmark Disabilities as envisaged under the regulations of Rights of Persons with Disabilities Act 2016 have been included presently, where only the lower motor disabilities were included earlier.

The qualified Persons with Disability (PwD) candidates should get themselves certified at one of the under mentioned Disability Assessment Boards, constituted in various states. The list of Centers who will issue Disability Certificates as per 21 Benchmark Disabilities given under RPWD Act-2016 is attached as ANNEXURE-II. The Board of Governors in Supersession of Medical Council of India has issued Guidelines regarding admission of students with "Specified Disabilities" under the Rights of Persons with Disabilities Act, 2016 vide Gazette Notification No. MCI-34(41)/2018-Med./170045 dated 5th February 2019 (Notification enclosed as ANNEXURE-III). The extent of "specified disability" in a Person with Disability (PwD candidate) shall be assessed in accordance with these guidelines for the purpose of issuing Disability Certificate and at the time of admission in the college. Further, all the PwD candidates participating in the PG Counselling 2019 are required to get themselves assessed for their disability and obtain a Disability (PwD) are required to bring their treatment papers related to their disability, including the investigation reports, at the time of reporting to the above-mentioned designated institutes for obtaining disability certificate.

IMPORTANT: Qualified PwD candidates are advised to get themselves examined **immediately** at one of the above-mentioned disability assessment board and to obtain Disability (PwD) Certificate. The qualified candidates are requested to send a self-attested photocopy of disability certificate with mention of their Name, All India Quota Rank, Postal Address, Mobile Telephone Number, alternative contact number and E-mail id by email (address: aiqpg-mcc@nic.in) and by Speed Post (to Assistant Director General (Medical Education), Room Number 354, A-Wing, Nirman Bhawan, Maulana Azad Road, New Delhi, Pin code 110108).

Q. No. 15: Is there any restriction for filling up number of choices of Institutions (Colleges) or subjects in choice filling form?

Ans: No, you can give as many choices as you wish. However, choices should be in order of preference, as the allotment is done on the basis of choices submitted by the qualified candidate in order of preference given by the candidate and as per availability.

Q. No. 16: Can I have some idea about the seat I am likely to get at my rank?

Ans: You can have some idea by logging on to www.mcc.nic.in / www.mohfw.nic.in website as follows:

>from home page go to medical counseling >open post-Graduate counseling (for previous years) >open composite allotment list.

From the information that you will see, you can get some idea of pattern in previous year(s). This will only be indicative (without any guarantee for the current year).

Q. No. 17: Is it necessary to fill up the choices and lock the choices to get seat allotted? Or I will be allotted seat automatically from available seats?

Ans: After online registration (registration is compulsory to take part in online allotment process), you have to fill in choice of subjects and Institutions/colleges in order of preference. Once choices are filled in, it can be modified before locking it. During the choice locking period it is necessary to lock the choices to get a print of your submitted choices. If candidate does not lock the choice submitted by him/her, they will be automatically locked on notified date at

notified time, however you will be allowed to take a print of your choices after that, but you will not be permitted to modify your choices.

If you don't register and fill in any choice, you will not be allotted any seat. If you register and do not fill in any choice, you will not be allotted any seat.

IMPORTANT:

Don't wait till the last minute to lock your choices and to take a printout. Please go through your submitted choices before locking as once you lock the choices the same cannot be modified or changed even if you have made a mistake. Mistake in filling choices may result in allotment of a seat which you never wanted. Also, it won't be possible to unlock your choices at MCC's end.

Q. No. 18: Is it necessary to join allotted Medical / Dental College to get chance to participate in next round (2nd Round)?

Ans: In case a seat is allotted during the Round-1 candidate may join the allotted institution/college and complete the admission formalities however candidates who have exited from Round I, availing the free exit may participate again in Round-2 after logging in with their earlier Registration details. In case of Free Exit after Round-1, Candidate has to report in person for Resignation / Surrender of allotted seat to the allotted College within stipulated time. Failing to do so the seat will not be deemed to be surrendered.

Please note that in case you do not give option to participate in Round-2 at the time of joining of seat allotted during Round-1, you will not be considered eligible for participating in Round-2 i.e. for up-gradation of your choice (only for those candidates who have joined & reported during Round-1 of Counseling).

Q. No. 19: What is second round of online allotment process?

Ans: Second round of online allotment process is Fresh Registration, Fresh choice filling and fresh allotment of seat as per choice and merit. There will be fresh registration of candidates and fresh Choice submission in 2nd Round for candidates who have not registered in 1st Round of Counselling and eligible candidates will be allotted seat on basis of choice and merit of the candidate.

Who are eligible for 2nd Round of allotment?

Candidates eligible for seat allotment in 2nd round would be from one of the following groups:

- **Group–I:** Registered candidates who participated in Round-2 but did not get any seat allotted in the 1st round.
- **Group-II:** Registered candidates, whose 1st round of allotted seat got Cancelled during the document verification on reporting for admission, **who have secured seat under reserved quota**, due to change of Category from reserved to Unreserved or PwD status from Yes to No, but are still eligible in the next round of seat allotment, with changed Category, subject to fulfillment of eligibility conditions.

- **Group–III:** Candidates who have reported/joined at allotted institute during the joining period of round-1 of allotment and submitted willingness for participating in second round upgradation as 'Yes'.
- **Group- IV:** Candidates who exited during Round-1 availing Free Exit can log in again with their earlier Registered details

Who are not eligible for 2nd Round of allotment?

• Candidates who do not have valid documents at the time of admission.

The conversion of seats will be carried out during the second round of seat allotment for AIQ and Mop Up Round for Deemed and Central Universities. Accordingly, the candidates are required to keep this aspect also in mind while filling up the seats during choice filling period before allotment of Round-1. The conversion of vacant reserved seats will be done as per the following algorithm after allotment of seat during Round-2 of All India Quota & Mop Up Round of Central Universities from PwD category candidates to other Reserved category candidates:

ST (PwD) - ST SC (PwD) - SC UR (PwD) - UR OBC (PwD) - OBC OBC / ST - SC SC - UR



Q. No. 20: Do I have to fill-up choices of subject and College to participate in second Round of online allotment process separately?

Ans: Yes, for Round-2 and Mop Up round of Deemed/ Central Universities, candidates are required to submit fresh choices. During the second round of online allotment process, the choice of higher preference will be considered for up-gradation for those candidates who give option to upgrade their choice at the time of admission at allotted Medical/Dental College. During Round-2, fresh allotment will be considered for those eligible candidates who could not be allotted seat due to non-availability of seat in Round-1, (subject to availability of seat) and for candidates who have logged in again in Round-2 after Free Exit from Round-1.

Q. No. 21: If sufficient number of qualified PwD candidates are not available then, what will happen to those un-allotted PG seats, reserved for PH candidates?

Ans: The un-allotted PG seats earmarked for UR-PwD, SC-PwD, ST-PwD and OBC- PwD will be reverted/converted to respective categories like SC-PwD to SC and so on, during the second Round of AIQ and Mop Up round (Central Universities) of allotment process after processing choices to PwD category candidates in second round and Mop Up Round.

Q. No. 22: If I give consent for up-gradation of my choice during Round-1 and if my choice is upgraded, is it necessary to join at college allotted during second round? Or in case I change my decision of upgrading choice, can I continue to study in college allotted through first round of allotment?

Ans: In case candidate is allotted seat during the Round-1 of allotment process and his choice is upgraded in Round-2, the seat allotted during the first round will be automatically cancelled immediately (and allotted to somebody else eligible as per merit) and candidate will have to join the college / seat allotted during second round. If candidate does not join the college/seat

allotted during the second round, with in stipulated time, as per schedule his Refundable Tuition fee will be forfeited. After joining the allotted institute in Round-2 the candidate will not be eligible to participate in any other round of counseling (For AIQ as well as Deemed / Central University counseling). The names of such candidates who have joined in Round-2 of AIQ / Deemed / Central Universities will be circulated to all state counseling authorities for prohibiting them to participate in any other counseling.

Seat can also be up-graded in the same college by change of category (i.e. ST / SC / OBC to UR or PwD to non-PwD seat) in such a case the candidate has to take fresh admission on the up-graded seat.

Q. No. 23: If I give option to participate in ROUND-2 at the time of joining college from first round allotment, but later change my decision and want to continue study at already allotted Medical / Dental College of Round-1, what is the procedure to avoid change (cancellation) of already allotted college/seat?

Ans: The candidate need not fill any fresh choices for Round-2 and the earlier seat will be retained.

Q. No. 24: If I forget my password that I have created during the process of registration, how to retrieve it?

Ans: To retrieve the forgotten password, system facilitates the following process:

The candidate is required to enter the information that he/she filled at the time of registration and then the security question & answer thereon to be entered as given during New Candidate registration process. The above data submitted by candidate will be validated with the registered candidates' database. If the above entries match, then only the candidate would be permitted to enter new password to proceed further.

IMPORTANT

Candidates are advised to remember the password and also retain their application form and admit cards printout ready till completion of admission process. It is not possible for MCC/NIC to retrieve such password.

Q. No. 25: In case I have Birth Certificate/Caste Certificate/other certificate(s) in regional language, will it be acceptable at the time of reporting/joining?

Ans: Certificates issued by the competent authority should be in English or Hindi language. Please remember that some of the states insist for certificate in English language only. Candidates are advised to carry Certified Copy of English version of the original certificate, in case certificate issued is in other than English language along with original certificate.

Q. No. 26: If there is discrepancy in spelling of name in documents and application form, what do I do?

Ans: If there is discrepancy in spelling in documents candidate must carry proof that the

Q. No. 27: Can I get prospectus (Information Bulletin) of All India Post Graduate Medical / Dental Entrance Examination for the current year for admission to All India Quota Post Graduate Medical / Dental courses for admission to 50% of total seats on All India basis?

Ans: Copy of prospectus is available on NBE website http://www.nbe.gov.in and www.mcc.nic.in for Medical /Dental Seats.

Q. No. 28: What about condition of Stipend / fee structure / course duration / bond amount / rendering of service in rural / tribal area / other conditionalities.

Ans: Stipend /fee structure/ course duration / bond amount / rendering of service in rural / tribal area/other conditions etc. may vary from State to State and Institute to Institute. Some seats may be approved/ permitted but not yet recognized by MCI. The allotment made through online allotment process will be firm and final as per Hon'ble Supreme Court's directions. Therefore, the candidates should well examine these points before opting for a seat at a medical college. The Medical Counseling Committee (MCC) shall neither be responsible nor shall entertain any case on above grounds, if any. The information received from various participating Medical/ Dental Colleges has been made available on Ministry of Health & Family Welfare / MCC website (under the Medical Counseling - Post-graduate Counseling - Information about college, fee, bond information etc.). Candidates are advised to visit the website of college/ institution to check the information. In case they require any additional information, they can contact the college / institution on telephone. MCC has no role in fixation of Fee Structure of Deemed Universities. Therefore, MCC of DGHS will not entertain any request or complaint regarding Fee Structure of Deemed Universities.

Q. No. 29: How to use registration and Choice filling form on website?

Ans: Candidates will have to log on to website www.mcc.nic.in to get registered (Registration facility will open on dates as mentioned in Schedule) and then fill in choices. It is advised that after going through the seat matrix, a tentative list may be prepared first as per your preference of subjects and colleges, before attempting to fill choices on-line.

Q. No. 30: Difficulty in login, what may be the problem(s)?

Ans: Please read User manual for the candidates. Follow the instructions about use of browser (Mozilla Fire Fox, Internet Explorer - (Latest Version), Google Chrome), use of same spellings, same format of date (Use digits for day, month and year with - in between) as in application form submitted to National Board Examination (NBE), New Delhi. The internet connection should be uninterrupted. If internet connection interruption takes place, the IP address which is being monitored will change and session expired message will be displayed. Please try to login from other computer from which other candidate(s) has logged in successfully, if possible.

Q. No. 31: I have difficulty in Creating Password, what may be the problem(s)?

Ans: Creation of password should be as per password policy. Please follow the password policy. Please use the internet browser as suggested in user manual, as it is difficult to login from some of the other browsers. While creating password avoid using Caps Lock key, instead of Caps Lock use shift key.

Q. No. 32: When I try to login for choice filling/submission, it say wrong roll number password, what may be problem(s)?

Ans: This can happen if Roll Number/Testing ID typed is incorrect or password typed is incorrect. Password is case sensitive, therefore use password which was created by user exactly same as typed while creating. In case password is forgotten, try to generate new password by using security question and its answer.

Q. No. 33: What are the guidelines for choice filling before round one of online allotment process and Round-2 Allotment Process?

Ans: The Candidates are advised to fill in choice carefully for seats in (Higher preference to lowest preference).

Q. No. 34: Can I modify my choices during the choice submission period for counseling?

Ans: Yes, you can modify, add or delete your choices during this period, before you lock your choices. However, the registration (of New Users) is permitted up to date and time specified in counselling Schedule, only.

Please note that you have to lock your choice by date and time specified in Counseling Schedule.

Q. No. 35: I have not locked my choices before the time specified in counseling schedule on last date of choice locking, what will happen to my choices?

Ans: The choices submitted and saved by you will be locked by the system at the time of last date/date of choice locking as mentioned in Counseling Schedule, automatically.

Q. No. 36: How can I get print out of my choices which system has locked?

Ans: After the specified time of last date/date of choice locking (or after choice locking) print out can be taken from MCC website after login by the Candidate, link is available on the left-hand side of the page as "Print Lock Choice".

Q. No. 37: If I opt to participate in second round of counseling whether my allotted seat (of first round) will be cancelled?

Ans: In case you are not allotted any seat in the second round you will retain earlier allotted seat (if you have already completed admission formalities and not resigned from the allotted seat). However, on allotment of a seat in second round the earlier allotted seat will automatically be cancelled and allotted to another candidate.

Q. No. 38: If I get an up-graded seat during second round of AIQ/ Deemed/ Central University from Round-1 can I join that college directly?

Ans: No, you will have to get a relieving letter from the earlier institute/college (of ROUND-1) generated on- line, before you can join the next college/institution.

Q. No. 39: In case I get an upgraded seat but in the same college, because of change of category, (e.g. from SC/ST/OBC to UR category) do I have to take admission on the allotted seat again?

Ans: Yes, you have to get a relieving letter generated on-line for the earlier seat and then get an admission letter again generated on-line for the upgraded category seat from the concerned institution; otherwise your seat would be cancelled or surrendered to state quota.

Q. No. 40: Can I know which of the seats are recognized or permitted by the MCI?

Ans: You may refer the MCI website, www.mciindia.org or Ministry of Health & Family Welfare website www.mohfw.nic.in for this.

Q. No. 41: At the time of admission will my original certificates be retained by the allotted college/institution?

Ans: Yes, all the participating colleges/institutions have been instructed to retain original certificates of admitted students and release them only on up-gradation of the seat or resignation by the candidate.

Q. No. 42: In case some of the Post-graduate seats are sanctioned by the Medical Council of India/ Central Government after start of Counseling (as per Counseling Schedule) will they be added in seat matrix (available seats)?

Ans: As per the "Time Schedule for completion of Admission Process for PG (Broad Speciality) Medical Courses for All India and State Quota" notified in the Gazette of India: Extraordinary, notification dated 29th December 2015, approved by the Hon'ble Supreme Court of India in IA Number 7 & 8 in Writ Petition (Civil) no. 76 of 2015 in Ashish Ranjan & Ors. Vs Union of India & ors. Case vide order dated 18.01.2016, "Institute/college/courses permitted after 28th February will not be considered for admission/allotment of seats for current academic year". As per Counseling Schedule (and MCI Admission Schedule) the 50% All India Quota Counseling will start after last date of issue of permission for starting

new courses/ increase of PG seats including existing and PG seats permitted up to 28th February (last date of issue of permission). Accordingly, Round-1 and 2 of 50% All India Quota Counseling will be conducted and there is no provision of Round-3. However, Exception to the Rule is Seats which are increased due to Teacher/ Student ratio and sanctioned by 10 A act, such seats can be added.

Q. No. 43: Will there be any Round 3 and 4 after completion of Round two of All India Quota Counseling?

Ans: As per the "Time Schedule for completion of Admission Process for PG (Broad Speciality) Medical Courses for All India and State Quota" notified in the Gazette of India: Extraordinary, notification dated 29th December 2015, approved by the Hon'ble Supreme Court of India in IA Number 7 &8 in Writ Petition (Civil) no. 76 of 2015 in Ashish Ranjan & Ors. Vs Union of India & ors. Case vide order dated 18/01/2016, there is provision of two Rounds only.

Q. No. 44: What will happen to seats which remain vacant after completion of Round two of All India Quota Counseling?

Ans: As per the "Time Schedule for completion of Admission Process for PG (Broad Speciality) Medical Courses for All India and State Quota" notified in the Gazette of India as per orders of Hon'ble Supreme Court of India in IA Number 7 &8 in Writ Petition (Civil) no. 76 of 2015 in Ashish Ranjan & Ors. Vs Union of India & Ors. Case, "All India Quota seats remaining vacant after last date for joining will be deemed to be converted into State quota".

Q. No. 45: What is the procedure for Mop Up Round Counseling which will be conducted by DGHS for Deemed & Central Universities?

Ans: The net vacant seats due to Non-Allotted, Non-Joining, Non-Reporting of Round-2 will be published in the seat matrix and eligible candidates have to submit fresh choices and the result will be processed as per Choice & Merit.

Q. No. 46: Who will be eligible for DGHS Mop Up Round for Deemed & Central Universities?

Ans: The Following categories of candidates are eligible for Mop Up Round

- a) Candidates who are registering for the first time.
- b) Candidates who have registered but not been allotted a seat in Round-1 & Round 2.
- c) All candidates except those who are holding a seat of Round-1 or Round 2.

Q. No. 47: Who will not be eligible for Mop Up Round of Counseling for Deemed/ Central Universities?

Ans: Candidates who have joined seat in Round-2 of Deemed/ Central Universities are not eligible.

Q. No. 48: What is the schedule for Counseling and Admission to PG Courses for the year 2019?

Ans: As per the schedule uploaded on the Website (www.mcc.nic.in).

Q. No. 49: What is the permissibility to students to exercise fresh choice during counseling?

Ans: The following Matrix explains the above question:

Q. No. 50: Are Andhra Pradesh & Telangana students eligible for All India Quota Counselling?

Ans: Yes, candidates who have completed MBBS/BDS from Andhra Pradesh & Telangana can participate in AIQ counseling.

Q. No. 51: How many rounds of counseling are for Deemed and Central Universities?

Ans: There will be three rounds of counseling for Deemed and Central Universities First, Second and Mop Up Round, followed by Stray Vacancy Round at the Institution Level (List of ten

times the number of vacancies will be sent by DGHS to Institutes which would be exhausted strictly in terms of merit).

Please see the schedule on the website.

Q. No. 52: Whether counseling will be conducted for 50% State Quota seats of Central Universities also, and for which universities?

Ans: Yes, counseling for 50% State quota seats as per the University eligibility condition will be conducted by MCC/ DGHS for Delhi University, BHU, AMU and institutional preference will be given to the candidates in 50% State Quota. It is to be noted that Rules & Regulations of Central Universities will apply. MCC of DGHS is only responsible for allotment of seats.

Q. No. 53: Whether Upgradation is allowed from 2nd round counseling of Deemed/ Central Universities to Mop Up Round counseling of DGHS for Central / Deemed Universities?

Ans: No, Upgradation is not allowed once a candidate joins a seat allotted in Round-2 of Deemed/Central Universities.

Q. No. 54: Whether the Tuition Fees which was submitted at the time of Registration will be refunded back in case the candidate is not allotted any seat during the two rounds of online counseling conducted by DGHS?

Ans: Yes, in case the candidate is not allotted any seat during the 2nd Round of AIQ and Mop Up Round of Deemed/ Central Universities, in such case the Tuition Fees will be refunded back to the same account of the candidate from which payment had been made.

Q. No. 55: What will be the eligibility criteria for 50% Institutional seats of Central Universities which is being conducted by DGHS?

Ans: The eligibility conditions of the 50% Institutional Quota of the Central Universities will be as per the eligibility given by the respective institutions at the time of counseling and the information will be put on MCC website. For additional information please contact the concerned University.

For admission to M.D. / M.S. / P.G. Diploma / M.D.S. Only those Candidates who have passed MBBS from Institute of Medical Sciences, BHU in December-2017 (Supplementary Batch by 31.3.2018) and have completed compulsory rotatory internship before 31.3.2019 will be considered for admission to M.D. / M.S. Course-2019 in IMS, BHU under internal (Institutional) quota pool, provided the candidate has appeared and qualified in NEET-PG 2019 examination. **BHU** Candidates who are already pursuing M.D. / M.S. course in IMS, BHU through internal (Institutional) quota OR passed MBBS from institute of Medical Sciences, BHU in earlier academic years (i.e. before December 2017) are not eligible for admission to PG Course-2019 under BHU internal (Institutional) quota. For Delhi University Quota: The candidate must have passed final M.B.B.S examination (for MD/MS/Diploma Course) and BDS examination (for MDS Course) from the University of Delhi and must have completed satisfactorily one-year compulsory rotating internship as on 31.03.2109 and must have submit their internship completion certificate at the time of admission. DU b) For All India Quota: The candidate must have passed final M.B.B.S examination (for MD/MS/Diploma Course) and BDS examination (for MDS Course) from the recognized Institution /University and must have completed satisfactorily oneyear compulsory rotating internship as on 31.03.2019 and must submit their internship completion certificate at the time of admission.

Q. No. 56: Whether there will be two separate counselling for All India Quota and 50% Institutional Quota on separate days and separate platform?

Ans: This time there is common counseling software for AIQ/ Deemed University/ Central Institutional Quota & ESIC. Hence, the candidates of 50% Institutional Quota who are eligible for counseling should opt for the choices in order of preference between AIQ and 50% Institutional Quota. The computer will allot the seat in order of choice and merit from the choices filled by the candidate. It is important to note that the preference would be given to the Institutional candidates for their eligible institutions as per the Institution's eligibility criteria.

Q. No. 57: I have registered for Round I. Should I register again for Round-2 and Mop Up Round?

Ans: No, only those candidates who have not registered in Round-1 need to register again.

Q. No. 58: What is the process of counseling for AFMS?

Ans: Candidates who are willing to participate in AFMS screening should register under AFMS at the time of Registration & fill their eligibility as per the 5 categories given by the AFMS authorities. Further round of Offline counseling will be conducted by AFMS authorities.

Q. No. 59: Who is Eligible for Stray Vacancy Round of Deemed/ Central Universities?

Ans: All Registered Candidates **except** the following three categories are eligible for Stray Vacancy Round of Deemed/ Central Universities:

- a) Candidates who joined the allotted seat in Round-2 of AIQ/ Deemed/ Central Universities.
- b) Candidates allotted a seat in Mop Up Round of DGHS
- c) Candidates joined a seat in Mop Up Round of DGHS.

Q. No. 60: Who are not eligible for Stray Vacancy Round of Deemed Universities?

Ans: Following Candidates are not eligible:

- a) Candidates who joined the allotted seat in Round-2 of AIQ/ Deemed/ Central Universities.
- b) Candidates allotted a seat in Mop Up Round of DGHS
- c) Candidates joined the allotted seat in Mop Up Round of DGHS.

Q. No. 61: Whether I am eligible for State/ DNB Counseling if allotted a seat in 2nd Round of DGHS?

Ans: If a candidate has been allotted a seat in Round-2 but not reported at the allotted Institute, he/she can exit with Forfeiture of Fees i.e. the Refundable Tuition Fee will be forfeited. However, once the candidate joins a seat allotted in 2nd Round (of AIQ/ Deemed University) he/she will not be eligible for exiting the seat and not eligible for any other round of Counseling including State and DNB Counseling. The names of such candidates who have joined in Round-2 of AIQ/ Deemed/ Central Universities will be circulated to all state counseling authorities for prohibiting them to participate in any other counseling.

The above rule is due to the direction of Hon'ble Supreme Court in Dar-Us- Slam case.

Q. No. 62: Who are eligible for "Exit with Forfeiture" option?

Ans:

- a) Candidate who has been allotted a seat in Round-2 but do not report at the college may Exit with Forfeiture. (i.e. The refundable tuition fee will not be refunded in such a case)
- b) Round-1 candidate who has not been Upgraded in Round-2 may resign his seat allotted in Round-1 within two days of Round-2 Result announcement without forfeiture of Tuition fees.

Please refer to Gazette Notification No. MCI-18(1)/2018-Med./100818 of Medical Council of India dated 5th April,2018 enclosed as ANNEXURE-IV.

Q. No. 63: What will happen to the All India Quota (50%) seats of Central Universities remaining vacant after the second round of All India Quota Counseling?

Ans: Seats of Central Universities remaining vacant after the second round of All India Quota Counseling will be considered in the mop-up round of the counselling conducted by MCC/DGHS.

Q. No. 64: Who are eligible for NRI Category?

Ans: Candidates who fall under the category of NRI as per the directions/ orders of Hon'ble Supreme Court of India in the case (W.P. (C) No. 689/2017- Consortium of Deemed Universities in Karnataka (CODEUNIK) & Anr. Vs. Union of India & Ors.) dated 22-08-2017 are eligible for NRI Category (order enclosed as ANNEXURE-V).

Q.No.65: Whether NRI category candidates are eligible for Management Quota seats as well?

Ans: Yes, the NRI category candidates are eligible for Management quota seats as well. The seats will be allotted to candidates in order of preference or choices filled by the candidate as per merit only.

Q. No. 66: What are the helpline numbers for PG Counselling & Finance related queries?

Ans: The following are numbers for PG Counselling & Finance related queries: 1800 102 7637, 0120-4073500.

Q. No. 67: How do I know the seat allotted to me is Recognized or Permitted?

Ans: Allotment of seats done by MCC is by computer software and does not differentiate between Recognized or Permitted. Only the allotted college would be able to tell whether the seat is Permitted or Recognized.

Ideally, the higher merit candidates will be given recognized seat and lower merit candidates would be given permitted seat.

Q. No. 68: How much money will be deducted as Transaction fee for Upgrading to next round or for Resignation?

Ans: Candidates are advised to contact college authorities regarding Transaction fee/ other related

fees before joining the college as MCC would not be responsible for any Refund related issues.

Q. No. 69: I have joined my allotted college of second round of counselling for All India Quota and now I am being offered another seat in State Quota / DNB, can I resign from my second round (AIQ) seat?

Ans: Once you have joined your second round allotted college of All India Quota you will not be allowed to resign from your All India Quota seat in compliance with the directions of the Hon'ble Supreme Court of India dated 09/05/2017 passed in Writ Petition[®] No.267 of 2017 -Dar-Us-Slam Educational Trust & Ors Vs MCI & Ors. Directorate General of health Services, Ministry of Health & Family Welfare.

Q. No. 70: I have joined my allotted college of second round of counselling for Deemed University now I am being offered another seat in State Quota /DNB, what is the process of resigning and the Bond to pay?

Ans: Once you have joined your allotted college in second round of Deemed University counselling you will not be allowed to resign from your Deemed University seat and will not be eligible for any further round of counselling in compliance with the directions of the Hon'ble Supreme Court of India dated 09/5/2017 passed in Writ Petition© No.267 of 2017 -Dar-Us-Slam Educational Trust & Ors. Vs MCI & Ors. Directorate General of health Services, Ministry of Health & Family Welfare.

Q. No. 71: I have not registered with the MCC during first, second and Mop Up round, now I want to register in the Stray Vacancy round during the ongoing counselling schedule, what is the process of registration?

Ans: Registration for Counselling conducted by MCC is only permitted during first second and Mop Up Round and no fresh registration can be done during stray vacancy round.

REFUND INFORMATION CLAUSE FAQ's regarding Defending

FAQ's regarding Refund Issues:

Q. No. 72: When and Where this Security amount will be refunded?

Ans:

- 1. Security amount will be refunded only after the completion of all rounds of Counseling i.e. after 31st May,2019.
- 2. The security amount will be refunded to the same account from where the security amount was initially deposited by the candidate. E.g. If the security amount was deposited through Card # 1234XXXXXXXX5678, then the refund will go to Card #1234XXXXXXXXX5678

only. If the security amount was deposited from account # 123456789012 of State Bank of India ISF Code SBIN0003567 then the refund will go to then the refund will go to # 123456789012 of State Bank of India ISF Code SBIN0003567 only.

Hence the candidate should keep their card/bank account active till refund process is completed.

Q. NO. 73: If the security deposit is remitted through unrelated card/bank account can the candidate request for refund to different card/bank account?

Ans: NO. As per FAQ Q. No. 13, the security deposit will be refunded only to the account from where the security deposit was initially deposited. The candidates are advised to not to use unrelated card/bank accounts for remitting security deposit. MCC will not entertain such requests.

Q. NO. 74: What happens if the candidate, by mistake, make more than one payment for the same Roll #?

Ans: Candidate can approach the Financial Custodian after 10 days of closing of Registration Window. The Financial custodian will refund the excess payment, if any, within 15days of receipt request from the candidate.

Q. NO. 75: Do I have to request the Financial Custodian to refund the security amount? What is the schedule for refund of security amount?

Ans: NO. Candidate need not approach the Financial Custodian for refund of security amount. The Medical Counselling Committee will publish the list of candidates who are eligible for the refund of security amount in the website of MCC "www.mcc.nic.in" as and when the counselling is completed. (Once all rounds of counselling are completed). The Financial Custodian will complete the refund of security amount within 15 working days of publishing the eligible list in the MCC Website. Once the Financial Custodian completes the refund, MCC will publish the refund details along with refund date & transaction # in the website of MCC "www.mcc.nic.in". The refund will be credited, depending upon the level of digitalization of candidate's bank, to the candidates account between 2 to 15 days from the date of refund by Financial Custodian.

Q. NO. 76: Can candidate initiate refund proceedings through chargeback claim through the card Issuing bank?

Ans: NO. Candidates who has been allotted Roll # should not initiate refund proceedings through chargeback claim through the card issuing bank. If the chargeback claim is initiated, the Financial Custodian will not be in a position to initiate direct refund.

Q. NO. 77: Who is the Financial Custodian?

Ans: HLL Lifecare Ltd, a Govt. of India Undertaking under Ministry of Health and Family Welfare is the Financial Custodian. They will, on behalf of MCC, collect non-refundable

Registration Fees and refundable security deposit from the candidates and refund the security deposit to the candidates.

Q. No. 78: How to contact the Financial Custodian?

Ans: The Financial Custodian Can be contacted through mail "<u>financemcc2019@lifecarehll.com</u>". The Financial custodian will respond only to the mails through mail id registered in the application form.

- > Direct queries to MCC will not be entertained.
- ➤ All refund related queries should be addressed to financemcc2019@lifecarehll.com only.

Q. No. 79: Will Medical Counselling Committee bear the bank charges incurred by the candidate while registering for counseling?

Ans: NO, Bank Charges if any, incurred by the candidate should be borne by them only.

Q. No. 80: Can candidate remit the Registration Fee and Security Deposit from NRI Account?

Ans: NO, since MCC cannot, as per Reserve Bank of India (RBI) Rules, refund security deposit to NRI Account. If the candidate wants to use the funds available in his/ her NRI Account for registering for counseling, he / she has to first transfer funds from NRI Account to NRO Account and from NRO Account to MCC. The refund from MCC will be credited to NRO Account only.

BOARD OF GOVERNORS IN SUPERSESSION OF MEDICAL COUNCIL OF INDIA AMENDMENT NOTIFICATION

New Delhi, the 4th February, 2019

No. MCI-34(41)/2018-Med./170045.—In exercise of the powers conferred by Section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Medical Council of India with the previous sanction of the Central Government, hereby makes the following Regulations to further amend the "Regulations on Graduate Medical Education, 1997", namely:

- 1. (i) These Regulations may be called the "Regulations on Graduate Medical Education(Amendment), 2019.
 - (ii) They shall come into force from the date of their publication in the Official Gazette.
- 2. In the "Regulations on Graduate Medical Education, 1997", under the heading of "Admission to the Medical Course-Eligibility Criteria" clause 4(3) shall be substituted as under:

To be eligible for admission to MBBS course, a candidate must have passed in the subjects of Physics, Chemistry, Biology (or Botany and Zoology)/Biotechnology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology (or Botany and Zoology)/Biotechnology at the qualifying examination as mentioned in clause (2) of Regulation 4 and in addition must have come in the merit list of "National Eligibility-cum-Entrance Test" for admission to MBBS course. In respect

of candidates belonging to Scheduled Castes, Scheduled Tribes or other Backward Classes the minimum marks obtained in Physics, Chemistry and Biology (or Botany and Zoology)/Bio-technology taken together in qualifying examination shall be 40% instead of 50%. In respect of candidates with specified disability under the Rights of Persons with Disabilities Act, 2016 the minimum marks in qualifying examination in Physics, Chemistry and Biology/Bio-technology taken together in qualifying examination shall be 45% instead of 50%.

Provided that a candidate who has appeared in the qualifying examination the result of which has not been declared, he/she may be provisionally permitted to take up the National Eligibility-cum-Entrance Test and in case of selection for admission to the MBBS course, he/she shall not be admitted to that course until he fulfils the eligibility criteria under Regulation 4.

5% of the annual sanctioned intake capacity in Government or Government aided higher educational institutions shall be filled up by candidates with benchmark disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, based on the merit list of 'National Eligibility-cum-Entrance Test'. For this purpose the "Specified Disability" contained in the Schedule to the Rights of Persons with Disabilities Act, 2016 is annexed in Appendix 'G' and the eligibility of candidates to pursue a course in medicine with specified disability shall be in accordance with Appendix 'H'. If the seats reserved for the persons with disabilities in a particular category remain unfilled on account of unavailability of candidates, the seats shall be included in the annual sanctioned seats for the respective Category.

3 In the "Regulations on Graduate Medical Education, 1997", after 7th row of Appendix-'F', the following row shall be added as under:

Guidelines regarding admission of students with "Specified Disabilities" under the Rights of Persons with Disabilities Act, 2016 with respect to admission in MBBS

Note 1. The "Certificate of Disability" shall be issued in accordance with the Rights of Persons with Disabilities Rules, 2017 notified in the Gazette of India by the by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 15th June 2017.

- 2. The extent of "specified disability" in a person shall be assessed in accordance with the "Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016 (49 of 2016)" notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 4th January 2018.
- 3. The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability.
- 4. The term 'Persons with Disabilities' (PwD) is to be used instead of the term 'Physically Handicapped' (PH)

सं. भा.बा.प.-18(1)/2018-मेड./100818.— भारतीय आयुर्विज्ञान परिषद् अधिनियम, 1956 (1956 का 102) की धारा 33 द्वारा प्रदत्त शक्तियों का इस्तेमाल करते हुए, भारतीय आयुर्विज्ञान परिषद् "स्नातकोत्तर चिकित्सा शिक्षा विनियमावली, 2000" में पुन: संशोधन करने के लिए केंद्र सरकार की पूर्व स्वीकृति से एतद्वारा निम्नलिखित विनियम बनाती है, नामत:-

- 1. (i) ये विनियम, "स्नातकोत्तर चिकित्सा शिक्षा (संशोधन) विनियमावली, 2018" कहे जाएंगे।
 - (ii) ये सरकारी राजपत्र में उनके प्रकाशन की तारीख से प्रवृत्त होंगे।
- 2. "स्नातकोत्तर चिकित्सा शिक्षा विनियमावली, 2000" के "स्नातकोत्तर चिकित्सा शिक्षा पाठ्यक्रम आरंभ करना और उनकी मान्यता" शीर्षक के अंतर्गत खंड 6(1), (2) और (3) को निम्नलिखित रूप में प्रतिस्थापित किया जाएगा:
 - "(1)कोई स्नातकोत्तर चिकित्सा शिक्षा पाठ्यक्रम आरंभ करने या पहले से चल रहे पाठ्यक्रम में वार्षिक प्रवेश क्षमता में वृद्धि करने का इच्छुक कोई संस्थान, अधिनियम की धारा 10 क के अंतर्गत केंद्र सरकार की पूर्वानुमित प्राप्त करेगा। स्नातकोत्तर डिग्री/स्नातकोत्तर डिप्लोमा पाठ्यक्रमों के लिए केंद्र सरकार द्वारा प्रदान की गई पूर्वानुमित क्रमश: चार और तीन शैक्षिक वर्षों के लिए होगी।

परंतु यह कि मेडिकल कालेजों/संस्थानों के लिए यह आवश्यक होगा कि वे मान्यता प्रदान किए जाने के तीन वर्ष अर्थात भारतीय आयुर्विज्ञान परिषद् अधिनियम, 1956 की प्रथम अनुसूची में की गई एमबीबीएस शैक्षिक योग्यता के शामिल किए जाने की तारीख से तीन वर्ष के अंदर स्नातकोत्तर चिकित्सा शिक्षा पाठ्यक्रम आंरभ करने के लिए आवेदन करें। स्नातकोत्तर पाठ्यक्रम आरंभ करने के लिए अनुबद्ध समय के अंदर आवेदन करने में विफल रहने पर, एम बी बी एस शैक्षिक योग्यता की मान्यता वापस लेनी आवश्यक हो जाएगी।

परंतु यह भी कि कोई ऐसे मेडिकल कालेज/चिकित्सा संस्थान, जो अननुमोदन की स्थिति में कोई स्नातकोत्तर पाठ्यक्रम आरंभ करने के लिए आवेदन करने के आगामी वर्षों के लिए दो और अवसर प्रदान किए जाएंगे। इसके पश्चात केंद्र सरकार की अनुमित प्राप्त करने में विफल रहने पर, एमबीबीएस शैक्षिक योग्यता की मान्यता वापस लेनी आवश्यक हो जाएगी।

(2) संस्थान, स्नातकोत्तर चिकित्सा शैक्षिक योग्यता की मान्यता के लिए संबद्धन विश्वविद्यालय के जिए केंद्र सरकार को आवेदन करेगा, जब दाखिल किया गया प्रथम बैच, संबद्धन विश्वविद्यालय द्वारा आयोजित की जाने वाली परीक्षा में बैठने के लिए नियत होगा।

मौजूदा पाठ्यक्रमों के लिए मान्यता प्राप्त करने में संस्थान के विफल रहने की स्थिति में, परिषद् केंद्र सरकार से निवारक शास्ति लगाने की अनुशंसा कर सकती है, जो स्नातकोत्तर पाठ्यक्रम की प्रति सीट दस लाख रुपये और/या संस्थान के अन्य स्नातकोत्तर चिकित्सा पाठ्यक्रमों के बंद किए जाने और/या किसी विनिदितर अविध के लिए स्नातकोत्तर पाठ्यक्रम आरंभ करने या सीटों में वृद्धि करने के लिए आवेदन करने से संस्थान को विवर्जित करने और/या एमबीबीएस में प्रवेश क्षमता को कम करने तक हो सकती है।"

- 4. "स्नातकोत्तर चिकित्सा शिक्षा विनियमावली, 2000" में "स्नातकोत्तर पाठ्यक्रमों के लिए अभ्यर्थी के चयन की प्रक्रिया" शीर्षक के अंतर्गत विनियम 9 को निम्नलिखित रूप में प्रतिस्थापित किया जाएगा:-

 - 2. पहले, नीट से संबंधित उपबंध, क्रिश्चियन मेडिकल कालेज, वैल्लोर और अन्य [2012 की टीसी (सी) संख्या 98 और 114 अन्य संबंधित याचिकाओं] के मामले में दिनांक 18 जुलाई, 2013 के अपने निर्णय के अंतर्गत माननीय उच्चतम न्यायालय द्वारा रद्द कर दिए गए है। तथापि, भारतीय आयुर्विज्ञान परिषद् और भारत की संघ सरकार द्वारा दायर की गई एक पुनर्विचार याचिका पर माननीय उच्चतम नयायालय ने, 'भारतीय आयुर्विज्ञान परिषद् बनाम क्रिश्चियन मेडिकल कालेज, वैल्लोर और अन्य' शीर्षक वाली 2013 की पुनर्विचार याचिका (सिविल) संख्या 2059-2268 में दिनांक 11 अप्रैल, 2016 के अपने आदेश के अंतर्गत नीट विनियमावली को पुनरजीवित कर दिया। शैक्षिक वर्ष 2017-18 के लिए स्नातकोत्तर पाठ्यक्रम में दाखिले, भारतीय आयुर्विज्ञान परिषद् (संशोधन) अधिनियम, 2016 के उपबंधों और माननीय उच्चतम न्यायालय द्वारा पुनरजीवित नीट विनियमावली के आधार पर और भारतीय आयुर्विज्ञान परिषद् (संशोधन) अधिनियम, 2016 की शर्तों के अनुसार राष्ट्रीय पात्रता व प्रवेश परीक्षा, स्नातकोत्तर स्तर पर सभी चिकित्सा शैक्षिक संस्थानों के लिए एक समान प्रवेश परीक्षा है और स्नातकोत्तर स्तर पर सभी चिकित्सा शैक्षिक संस्थानों के लिए एक समान प्रवेश परीक्षा है और स्नातकोत्तर स्तर पर सभी चिकित्सा शैक्षिक संस्थानों के लिए एक समान प्रवेश परीक्षा बनी रहेगी।
- 9. स्नातकोत्तर पाठ्यक्रमों के लिए अभ्यर्थियों के चयन की प्रक्रिया निम्नलिखित होगी:-
 - (1) प्रत्येक शैक्षिक वर्ष स्नातकोत्तर पाठ्यक्रमों में दाखिले के लिए स्नातकोत्तर स्तर पर सभी चिकित्सा शैक्षिक संस्थानों के लिए एक समान प्रवेश परीक्षा नामत: 'राष्ट्रीय पात्रता व प्रवेश परीक्षा' होगी और यह स्वास्थ्य एवं परिवार कल्याण मंत्रालय, भारत सरकार के समग्र पग्रवेक्षण के अधीन आयोजित की जाएगी।

- (2) "राष्ट्रीय पात्रता व प्रवेश परीक्षा" आयोजित करने के लिए 'नामित प्राधिकारी' राष्ट्रीय परीक्षा बोर्ड या स्वास्थ्य एवं परिवार कल्याण मंत्रालय, भारत सरकार द्वारा नामित कोई अन्य निकाय/संगठन होगा।
- (3) किसी शैक्षिक वर्ष के लिए स्नातकोत्तर पाठ्यक्रम में दाखिले हेतु पात्र बनने की दृष्टि से किसी अभ्यर्थी के लिए यह आवश्यक होगा कि वह उक्त शैक्षिक वर्ष के लिए आयोजित की गई स्नातकोत्तर पाठ्यक्रमों हेतु पात्रता 'राष्ट्रीय पात्रता व प्रवेश परीक्षा' में 50 वें पर्सेटाइल पर न्यूनतम अंक प्राप्त करे। तथापि, अनुसूचित जातियों, अनुसूचित जनजातियों और अन्य पिछड़ा वर्गों से संबंधित अभ्यर्थियों के संबंध में न्यूनतम अंक 40 वें पर्सेटाइल पर होंगे। विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 के अंतर्गत विनिर्दिष्ट बैंच मार्क विकलांगताओं वोले अभ्यर्थियों के संबंध में न्यूनतम अंक सामान्य श्रेणी के लिए 45 वें पर्सेटाइल पर और अ.जा./अ.ज.जा./अ.पि.व.के लिए 40 वें पर्सेटाइल पर होंगे। पर्सेटाइल, स्नातकोत्तर पाठ्यक्रमों के लिए 'राष्ट्रीय पात्रता व प्रवेश परीक्षा' में अखिल भारतीय सामूहिक मेरिट सूची में प्राप्त उच्चतम अंकों के आधार पर निर्धारित की जाएगी।

परंतु यह कि जब संबंधित श्रेणियों में पर्याप्त संख्या में अभ्यर्थी स्नातकोत्तर पाठ्यक्रमों में दाखिले कि लिए किसी शैक्षिक वर्ष हेतु आयोजित राष्ट्रीय पात्रता व प्रवेश परीक्षा में यथा विनिर्धारित न्यूनतम अंक प्राप्त करने में विफल रहते हैं तो भारतीय आयुर्विज्ञान परिषद् के परामर्श से केंद्र सरकार अपने विवेक पर, संबंधित श्रेणियों से संबंधित अभ्यर्थियों के लिए स्नातकोत्तर पाठ्यक्रम में दाखिले के लिए अपेक्षित न्यूनतम अंक कम कर सकती है और केंद्र सरकार द्वारा इस प्रकार कम किए अंक केवल उसी शैक्षिक वर्ष के लिए लागू होंगे।

(4) संबंधित श्रेणियों के लिए, मेडिकल कालेजों/संस्थानों में सीटों का आरक्षण, राज्यों/संघ शासित क्षेत्रों में प्रचलित लागू होने वाले कानूनों के अनुसार होगा। पात्र अभ्यर्थियों की अखिल भारतीय मेरिट सूची और राज्य-वार मेरिट सूची, 'राष्ट्रीय पात्रता व प्रवेश परीक्षा' में प्राप्त अंकों के आधार पर तैयार की जाएगी और अभ्यर्थियों को केवल उक्त मेरिट सूचियों से स्नातकोत्तर पाठ्यक्रमों में दाखिल किया जाएगा।

(5) वार्षिक स्वीकृत प्रवेश क्षमता की 5% सीटें, स्नातकोत्तर चिकित्सा पाठ्यक्रमों में दाखिले के लिए 'राष्ट्रीय पात्रता व प्रवेश परीक्षा' की मेरिट सूची के आधार पर, विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 के उपबंधों के अनुसार बैंचमार्क विकलांगताओं वाले व्यक्तियों द्वारा भरी जाएंगी।

किसी शैक्षिक वर्ष के लिए स्नातकोत्तर पाठ्यक्रम में दाखिले हेतु पात्र बनने की दृष्टि से किसी अभ्यर्थी के लिए यह आवश्यक होगा कि वह उक्त शैक्षिक वर्ष के लिए आयोजित की गई स्नातकोत्तर पाठ्यक्रमों हेतु पात्रता 'राष्ट्रीय पात्रता व प्रवेश परीक्षा' में 50 वें पर्सेंटाइल पर न्यूनतम अंक प्राप्त करे। तथापि, अनुसूचित जातियों, अनुसूचित जनजातियों और अन्य पिछड़ा वर्गों से संबंधित अभ्यर्थियों के संबंध में 40 वें पर्सेंटाइल पर न्यूनतम अंक होंगे। विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 के अंतर्गत अविनिर्दिष्ट बैंच मार्क विकलांगताओं वोले अभ्यर्थियों के संबंध में सामान्य श्रेणी के लिए न्यूनतम अंक 45 वें पर्सेंटाइल पर और अ.जा./अ.ज.जा./अ.पि.व.के लिए 40 वें पर्सेंटाइल पर होंगे।

- (6) किसी ऐसे अभ्यर्थी, जो ऊपर उप-खंड (3) में यथा विनिर्धारित न्यूनतम पात्रता अंक प्राप्त करने में विफल रहा है, को उक्त शैक्षिक वर्ष में किसी स्नातकोत्तर पाठ्यक्रम में दाखिल नहीं किया जाएगा।
- (7) गैर सरकारी मेडिकल कॉलेजों/संस्थानों में, कुल सीटों में से 50% (पचास प्रतिशत) सीटें राज्य सरकार या उनके द्वारा नियुक्त प्राधिकारी द्वारा भरी जाएंगी और शेष 50% (पचास प्रतिशत) सीटें "राष्ट्रीय पात्रता व प्रवेश-परीक्षा" में प्राप्त अंकों के आधार पर बनाई गई मेरिट सूची के अनुसार संबंधित मेडिकल कॉलेजों/संस्थानों द्वारा भरी जाएंगी।
- (8) स्नातकोत्तर डिप्लोमा पाठ्यक्रमों में 50% सीटें, सरकारी सेवा में ऐसे चिकित्सा अधिकारियों के लिए आरक्षित होंगी, जिन्होंने दूर-दराज के और/या दुर्गम्य क्षेत्रों और/या ग्रामीण क्षेत्रों में कम से कम तीन वर्ष तक सेवा की है।

स्नातकोत्तर डिप्लोमा प्राप्त करने के पश्चात ये चिकित्सा अधिकारी, समय-समय पर राज्य सरकार/सक्षम प्राधिकारी द्वारा यथा परिभाषित दूर-दराज के और/या दूर्गम्य क्षेत्रों में दो और वर्ष तक सेवा करेंगे।

- (11) कोई भी प्राधिकारी/संस्थान, इन विनियमों द्वारा यथा विनिर्धारित मापदंड/प्रक्रिया का उल्लंघन करके और/या दाखिलों के संबंध में माननीय उच्चतम न्यायालय द्वारा पारित निर्णयों का उल्लंघन करके, किसी स्नातकोत्तर मेडिसिन पाठ्यक्रम में किसी अभ्यर्थी को दाखिल नहीं करेगा। उपर्युक्त का उल्लंघन करके दाखिल किए गए किसी अभ्यर्थी को परिषद् द्वारा तुरंत निकाल दिया जाएगा। ऐसे प्राधिकारी/संस्थान, जो इन विनियमों और/या माननीय उच्चतम न्यायालय द्वारा पारित निर्णयों का उल्लंघन करके किसी छात्र को दाखिला प्रदान करता है, उसके विरूद्ध ऐसी कार्रवाई की जा सकेगी जो परिषद् द्वारा विनिर्धारित की जाए, जिसमें आगामी शैक्षिक वर्ष/वर्षों के लिए उसकी स्वीकृत प्रवेश क्षमता से, किए गए ऐसे दाखिलों की सीमा के समतुल्य सीटों का अभ्यर्पण शामिल है।"
- 5. स्नातकोत्तर चिकित्सा शिक्षा विनियमावली में 9 क (3) के पश्चात निम्नलिखित खंड जोडा जाएगा:-
 - 9 क (4) स्नातकोत्तर पाठ्यक्रमों में दाखिले के लिए सामूहिक परामर्श में सीट ब्लाकिंग और परामर्श के दौरान नया विकल्प चुनने की अनुमेयता रोकने की दृष्टि से, शुल्क की जब्ती, परिशिष्ट-III में दिए गए मापदंडों के अनुसार होगी।
- 6. " स्नातकोत्तर चिकित्सा शिक्षा विनियमावली, 2000" में, स्टाफ संकाय शीर्षक के अंतर्गत खंड 11.1 (क) में निम्नलिखित अभिवर्धन किया जाएगा, दूसरे परंतुक के पश्चात निम्नलिखित जोड़ा जाएगा:

MEDICAL COUNCIL OF INDIA NOTIFICATION

New Delhi, the 5th April, 2018

No. MCI-18(1)/2018-Med./100818.— In exercise of powers conferred by Section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Medical Council of India with the previous sanction of the Central Government hereby makes the following regulations to further amend the "Postgraduate Medical Education Regulations, 2000." namely:-

- 1. (i) These regulations may be called the "Postgraduate Medical Education (Amendment) Regulations, 2018".
- (ii) They shall come into force from the date of their publication in the Official Gazette.
- Clause 6(1), (2) & (3) under the heading "Starting of postgraduate Medical Courses and their recognition" of the "Postgraduate Medical Education Regulations, 2000", shall be substituted as under:-
 - An institution intending to start a post-graduate medical education course or to increase the annual intake capacity in an already ongoing course shall obtain the prior permission of the Central Government under section 10A of the Act. The prior permission granted by the Central Government for Postgraduate Degree/Postgraduate Diploma courses shall be for four and three academic years respectively Provided that it shall be incumbent upon Medical Colleges/Medical Institutions to make an application for starting of Post-graduate medical education courses within three years of grant of recognition, i.e., three years from the date of inclusion of the MBBS qualification awarded by the Medical College in the First Schedule of the Indian Medical Council Act, 1956. Failure to make an application for starting of Postgraduate courses within the stipulated time shall entail the withdrawal of recognition of MBBS qualification. Provided further that a Medical College/Medical Institution that makes an application for starting of a Postgraduate course in the eventuality of disapproval shall be granted two more opportunities for the succeeding years to make an application. Failure to obtain permission of the Central Government thereafter shall entail the withdrawal of Recognition of MBBS qualification.' Provided further that above shall be applicable to the scheme submitted from the academic year 2020-21 onwards, in order to provide time to the existing colleges to apply.
 - (2) The Institution shall apply for recognition of the Post Graduate Medical qualification to the Central Government through the affiliating University, when the first admitted batch shall be due to appear for the examination to be conducted by the affiliating University.
 - In the event of deficiencies being found in the assessment, the Institution shall be granted an opportunity to submit compliance within 30 days from the date of communication of deficiencies by the Council. Such an opportunity to comply with the deficiencies shall be availed by the Institute only twice. The Postgraduate Medical Education Committee on finding the compliance satisfactory shall convey the recommendation to recognize the course. In all others cases, the prior permission of the Central Government granted under sub-clause (1) shall be deemed to have lapsed after four and three years for Postgraduate Degree/Postgraduate Diploma courses respectively. Further, in such cases; recommendation shall be made to the Central Government to include the qualifications in the First Schedule of the Indian Medical Council Act, 1956 only in respect of first four batches of Postgraduate Degree Courses and three batches of Postgraduate Diploma courses.
 - (3) Failure to seek timely recognition as required in sub-clause 2 shall invariably result in stoppage of admission to the concerned Post Graduate course.
 - In the event of failure of the institute to seek recognition for existing Post Graduate courses, the Council may recommend to the Central Government for imposition of exemplary penalty which may extend to Rupees ten lakhs per seat of the postgraduate course; and/or stoppage of other postgraduate Medical courses of the Institution; and/or debar the Institution from making any application for starting or increase of seats in postgraduate courses for a specified period; and/or reducing the intake capacity in MBBS."
- 3. Clause 8(1) under the heading "General" of the "Postgraduate Medical Education Regulations, 2000", shall be substituted as under:-
 - "The Medical Institution recognized under the Indian Medical Council Act, 1956 for running post-graduate courses prior to the commencement of the Indian Medical Council (Amendment) Act, 1993; the Medical

Colleges recognised for running Bachelor of Medicine and Bachelor of Surgery (MBBS) course; and the Medical Institutions established by the Central Government for the purpose of imparting postgraduate medical education shall be eligible for starting a post-graduate medical education course or to increase the intake capacity in any already ongoing postgraduate medical education course.

Provided that it shall be permissible for Medical Colleges not yet recognized for the award of MBBS degree under the Indian Medical Council Act, 1956 to apply for starting of a Post-graduate medical education course in pre clinical and para clinical subjects, namely, Anatomy; Physiology; Biochemistry; Pharmacology; Pathology; Microbiology; Forensic Medicine; and Community Medicine at the time of third renewal i.e., alongwith the admission of fourth batch for the MBBS course; and in clinical subjects, namely, Anaesthesiology; Dermatology, Venerology and Leprosy; General Medicine; Paediatrics; Psychiatry; Radiodiagnosis; Radiation Oncology; Respiratory Medicine; Otorhinolaryngology; General Surgery; Ophthalmology; Orthopaedics; Obstetrics & Gynaecology, at the time of fourth renewal, i.e., along with the admission of fifth batch for the MBBS course."

4. In the "Postgraduate Medical Education Regulations, 2000", in Regulation 9 under the heading "Procedure for selection of candidate for Postgraduate courses" shall be substituted as under:-

Preamble

- 1. The Parliament of India has amended the Indian Medical Council Act, 1956 by the Indian Medical Council (Amendment) Act 2016. This Amendment Act after receiving the assent of the President has been notified in the Gazette of India on 5th August 2016. The Indian Medical Council (Amendment) Act 2016 has inserted section 10 D and section 33 (mb) to the Indian Medical Council Act, 1956. The said provision provides for a uniform entrance examination to all medical educational institutions at the under graduate level and post graduate level by the "designated authority". By virtue of this Amendment the Parliament has provided legislative sanctity to the National Eligibility-Cum-Entrance Test [hereinafter "NEET"] included in the Post-Graduate Medical Education Regulations, 1997 by Amendments notified in the Official Gazette on 27th December 2010, 27th February 2012 and 23rd October 2012.
- 2. Earlier the provisions relating to NEET were quashed by the Hon'ble Supreme Court vide its judgment dated 18th July 2013 in Christian Medical College Vellore & Ors. (TC (C) No. 98 of 2012 and other 114 connected petitions). However, on a Review Petition preferred by the Medical Council of India and the Union of India, the Hon'ble Supreme Court vide its order dated 11th April 2016 in Review Petition (c) Nos. 2059-2268 of 2013 captioned as Medical Council of India vs. Christian Medical College Vellore & Ors. has revived NEET Regulations. The admission to postgraduate courses for the academic year 2017-18 were conducted on the basis of provisions of the Indian Medical Council (Amendment) Act, 2016 and the NEET Regulations revived by the Hon'ble Supreme Court and in the Terms of the Indian Medical Council (Amendment) Act, 2016 the National Eligibility-cum-Entrance Test is the uniform entrance examination to all medical educational institutions at the post graduate level and shall continue to be the uniform entrance examination to all medical educational institutions at the post graduate level.
- Procedure for selection of candidate for Postgraduate courses shall be as follows:-
 - (1) There shall be a uniform entrance examination to all medical educational institutions at the Postgraduate level namely 'National Eligibility-cum-Entrance Test' for admission to postgraduate courses in each academic year and shall be conducted under the overall supervision of the Ministry of Health & Family Welfare, Government of India.
 - (2) The "designated authority" to conduct the 'National Eligibility-cum-Entrance Test' shall be the National Board of Examination or any other body/organization so designated by the Ministry of Health and Family Welfare, Government of India.
 - (3) In order to be eligible for admission to Postgraduate Course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the 'National Eligibility-Cum-Entrance Test for Postgraduate courses' held for the said academic year. However, in respect of candidates belonging to Scheduled Castes, Scheduled Tribes, and Other Backward Classes, the minimum marks shall be at 40th percentile. In respect of candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks shall be at 45th percentile for General Category and 40th percentile for SC/ST/OBC. The percentile shall be determined on the basis of highest marks secured in the All India Common merit list in National Eligibility-cum-Entrance Test for Postgraduate courses.

Provided when sufficient number of candidates in the respective categories fail to secure minimum marks as prescribed in National Eligibility-cum-Entrance Test held for any academic year for admission to Postgraduate Courses, the Central Government in consultation with Medical Council of India may at its

- discretion lower the minimum marks required for admission to Post Graduate Course for candidates belonging to respective categories and marks so lowered by the Central Government shall be applicable for the academic year only.
- (4) The reservation of seats in Medical Colleges/institutions for respective categories shall be as per applicable laws prevailing in States/Union Territories. An all India merit list as well as State-wise merit list of the eligible candidates shall be prepared on the basis of the marks obtained in National Eligibility-cum-Entrance Test and candidates shall be admitted to Postgraduate Courses from the said merit lists only.
 - Provided that in determining the merit of candidates who are in service of government/public authority, weightage in the marks may be given by the Government/Competent Authority as an incentive upto 10% of the marks obtained for each year of service in remote and/or difficult areas or Rural areas upto maximum of 30% of the marks obtained in National Eligibility-cum Entrance Test. The remote and/or difficult areas or Rural areas shall be as notified by State Government/Competent authority from time to time."
- (5) 5% seats of annual sanctioned intake capacity shall be filled up by persons with benchmark disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, based on the merit list of National Eligibility-Cum-Entrance Test for admission to Postgraduate Medical Courses.
 - In order to be eligible for admission to Postgraduate Course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the 'National Eligibility-Cum-Entrance Test for Postgraduate courses' held for the said academic year. However, in respect of candidates belonging to Scheduled Castes, Scheduled Tribes, and Other Backward Classes, the minimum marks shall be at 40th percentile. In respect of candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks shall be at 45th percentile for General Category and 40th percentile for SC/ST/OBC.
- (6) No candidate who has failed to obtain the minimum eligibility marks as prescribed in Sub-Clause (3) above shall be admitted to any Postgraduate courses in the said academic year.
- (7) In non-Governmental medical colleges/institutions, 50% (Fifty Percent) of the total seats shall be filled by State Government or the Authroity appointed by them, and the remaining 50% (Fifty Percent) of the seats shall be filled by the concerned medical colleges/institutions on the basis of the merit list prepared as per the marks obtained in National Eligibility-cum-Entrance Test."
- (8) 50% of the seats in Postgraduate Diploma Courses shall be reserved for Medical Officers in the Government service, who have served for at least three years in remote and /or difficult areas and / or Rural areas. After acquiring the Postgraduate Diploma, the Medical Officers shall serve for two more years in remote and /or difficult areas and / or Rural areas as defined by State Government/Competent authority from time to time.
- (9) The Universities and other authorities concerned shall organize admission process in such a way that teaching in broad speciality postgraduate courses starts by 1st May and for super speciality courses by 1st August each year. For this purpose, they shall follow the time schedule indicated in Appendix-III.
- (10) There shall be no admission of students in respect of any academic session beyond 31st May for postgraduate courses and 31st August for super speciality courses under any circumstances. The Universities shall not register any student admitted beyond the said date.
- (11) No authority / institution shall admit any candidate to any postgraduate medicine course in contravention of the criteria / procedure as laid down by these Regulations and / or in violation of the judgements passed by the Hon'ble Supreme Court in respect of admissions. Any candidate admitted in contravention / violation of aforesaid shall be discharged by the Council forthwith. The authority / institution which grants admission to any student in contravention / violation of the Regulations and / or the judgements passed by the Hon'ble Supreme Court, shall also be liable to face such action as may be prescribed by the Council, including surrender of seats equivalent to the extent of such admission made from its sanctioned intake capacity for the succeeding academic year / years."
- 5. In the Postgraduate Medical Education Regulations following clause shall be added after 9A(3):-
 - 9A(4) In order to prevent seat blocking in common counseling for admission to Postgrauate Courses and permissibility to exercise fresh choice during Counseling, forfeiture of fee shall be in accordance with the matrix contained in appendix-III.
- 6. In the "Postgraduate Medical Education Regulations, 2000", the following additions in clause 11.1(a) under the heading Staff – Faculty, the following shall be added after the second proviso:
 - Minimum staff required (Broad speciality):

(First Unit)

- 1-Professor
- 1-Associate Professor
- 1- Assistant Professor
- 1-Senior Resident
- 2-Junior Resident

Remaining units of the department (in multi unit departments) can be headed by Professor or Associate Professor and remaining two faculties can be Assistant Professor in addition to one Senior Resident and two Junior Resident

The above definition shall not apply to the Departments of Critical Care/Departments with day care services such as Respiratory Medicine/ Dermatology Venereology Leprosy/Ophthalmology/Otorhinolaryngology etc. The Council also decided to include the requirement of Residents in all departments in the Postgraduate.

7. In the "Postgraduate Medical Education Regulations, 2000", the following additions in clause 11.1(b) under the heading Staff – Faculty, the following shall be added after the third proviso:

Minimum staff required (Super-speciality):

(First Unit)

- 1-Professor
- 1-Associate Professor.
- 1- Assistant Professor
- 1-Senior Resident
- 2-Junior Resident

Remaining units of the department (in multi-unit departments) can be headed by Professor or Associate Professor and remaining two faculties can be Assistant Professor in addition to one Senior Resident and two Junior Resident.

8. Clause 12(1) under the heading "Number of Postgraduate students to be admitted" of the "Postgraduate Medical Education Regulations, 2000", following shall be substituted/added:-

The word Radiotherapy shall be substituted as "Radiation Oncology" in 2nd paragraph

After Third paragraph following shall be added:-

Provided further that in non-governmental Medical Colleges/Medical Institution, the application for increase of seats on the basis of said ratio shall be considered only if the College/Institute:-

- 1. Has a standing of 15 years
- 2. Should be running the Postgraduate course since 10 years
- 3. Should have completed at least 1 continuance of recognition assessment satisfactorily and
- Applies u/s 10A of the Indian Medical Council Act, 1956 for increase of seats which would be granted only after physical verification of faculty, resident, clinical material and infrastructural facilities etc.
- 9. Clause 13(2) under the heading "TRAINING PROGRAMME" of the "Postgraduate Medical Education Regulations, 2000", in third line "each academic year" shall be substituted as under:-
 - "Academic Term of 6 months"
- 10. Clause 14 under the heading "EXAMINATION" of the "Postgraduate Medical Education Regulations, 2000", following shall be substituted as under:-
 - Obtaining a minimum of 40% marks in each theory paper and not less than 50% cumulatively in all the four papers for degree examinations and three papers in diploma examination. Obtaining of 50% marks in Practical examination shall be mandatory for passing the examination as a whole in the said degree/diploma examination as the case may be.
- 11. In the Postgraduate Medical Education Regulations, 2000, in appendix the following note shall be added below the Admission schedule from the academic year 2018-19 onwards for Postgraduate Courses (broad Speciality):-

Note:

- All India Quota Seats remaining vacant after last date for joining, i.e 10th May will be deemed to be converted into State Quota.
- Institute/College/Courses permitted after 28th February will not be considered for admission/allotment of seats for current academic year.
- 3. In any circumstances, last date for admission/joining will not be extended after 31st May.
- 4. For the purpose of ensuring faithful obedience to the above time-schedule, Saturday, Sunday or Holidays (except National Holiday) shall be treated as working day.
- 5. The following Matrix shall be applicable with regard to permissibility to students to exercise fresh choice during counseling: -

UPON hearing the counsel the Court made the following O R D E R

Heard Dr. Rajeev Dhawan, learned senior counsel along with Ms. Farah Fathima, learned counsel for the petitioners, Mr. P.S. Narasimha, learned Additional Solicitor TANKANA General for the Union of India and Mr. Gaurav Sharma, learned counsel for the Medical Council of India.

The matter was listed today for consideration of the filling up of NRI quota seats. Dr. Rajeev Dhawan, learned senior counsel appearing for the petitioners has drawn our attention to the letter circulars dated 13th July, 2017 and 28th July, 2017, issued by the Directorate General of Health Services. According to him, the said communications create an anomalous situation as a consequence of which the description of NRI has become extremely difficult. He has drawn our attention to a passage from P.A. Inamdar vs. State of Maharashtra (2005) 6 SCC 537, wherein the Constitution Bench has held thus:-

"Here itself we are inclined to deal with the question as to seats allocated for Non-Resident Indians ('NRI', for short) or NRI seats. It is common knowledge that some of the institutions grant admissions to a certain number of students under such quota by charging a higher amount of fee. In fact, the term 'NRI' in relation to admissions is a misnomer. By and large, we have noticed in cases after cases coming to this Court, neither the students who get admissions under this category nor their parents are NRIs. In effect and reality, under this category, less meritorious students, but who can afford to bring more money, admission. During the course of hearing, it was pointed out that a limited number of such seats should be made available as the money brought by such students admitted against NRI quota institutions educational the enables strengthen their level of education and also to enlarge their education activities. It was also pointed out that people of Indian origin, who have migrated to other countries, have a desire to bring back their children to their own country as they not only get education but also get reunited with Indian cultural ethos by virtue of being here. They also wish the money which they would be spending elsewhere on education of their children should rather reach their own motherland. A limited reservation of such seats, not exceeding 15%, in our opinion, may be made available to NRIs depending on the discretion of the management subject to two seats should such First, conditions.

utilized bona fide by the NRIs only and for their children or wards. Secondly, within this quota, the merit should not be given a complete go-by. The amount of money, in whatever form collected from such NRIs, should be utilized benefiting students such economically weaker sections of the society, whom, on well defined criteria, the educational institution may admit on subsidized payment of their fee. To prevent misutilisation of such quota or any malpractice referable to NRI quota seats, suitable legislation or regulation needs to be framed. So long as the State does not do it, it will be for the Committees constituted pursuant to the direction in Islamic Academy to regulate."

Submission of learned senior counsel is that the word "wards" used in the said paragraph should be understood in a broader compass and be applied in a wider spectrum. He has also drawn our attention to the decision rendered in Ruchin Bharat Patel vs. Parents' Association for the M/D Students and Others in I.A. Nos.9-10 & 11-12 in Civil Appeal No.4480 of 2006, wherein this Court after referring to various aspects, has held thus:-

"Normally, the admissions to the colleges should have been finally concluded before 30th September. This year's admission is long overdue and if this 15% of the students are not allowed to be admitted under NRI quota there may be financial loss to these college and the seats shall also go waste. In view of the peculiar circumstances of the case, for this year we are taking a practical view of the situation and we feel that the students to these colleges may be admitted under the following directions and we make it clear that this is exclusively for this year only as a one time arrangement because of the circumstances of the case:-

"1) The students be admitted as NRIs in NRI quota as against 15%: At least one of the parents of such students should be an NRI and shall ordinarily be residing abroad as an NRI;

- 2) The person who sponsors the student for admission should be a first degree relation of the student and should be ordinarily residing abroad as an NRI;
- 3) If the student has no parents or near relatives or taken as a ward by some other nearest relative such students also may be considered for admission provided the guardian has bona fide treated the student as a ward and such guardian shall file an affidavit indicating the interest shown in the affairs of the student and also his relationship with the student and such person also should be an NRI, and ordinarily residing abroad."

Even if these parameters are applied and sufficient number of students are not available for this year as against admission to 15% quota, the colleges would be at liberty to fill up the remaining seats from the State list and if the number of candidates admitted as against 15% quota is very much less and the colleges are unable to raise sufficient funds, they would be at liberty to approach the Committee to restructure the fees."

In this regard our attention has been invited to a Division Bench decision of the High Court of Madhya Pradesh rendered in <u>Anshul Tomar</u> vs. <u>State of M.P. and Others</u> (2008) 2 MPLJ 450, wherein the High Court after referring to the authority in <u>Ruchin Bharat Patel</u> (supra) has referred to a authority in <u>Ruchin Bharat Patel</u> (supra) has referred to a set of guidelines drafted by Pravesh Niyantran Samiti (Medical Education), Mumbai. The said guidelines read as follows:-

"Based upon the decision of Hon'ble Supreme Court referred herein above dated 13th November, 2006 has laid down a criteria for admission in NRI quota, the Samiti decides and resolves the criteria for granting the admissions in NRI quota, as under:

 If the mother or father of student is NRI and residing abroad ordinarily, then, either of the situations so held will be considered to be proper.

- 2) If the first degree relation of the student is NRI and residing abroad ordinarily, then in such circumstances also, qua this year, should be considered eligible. It is natural that such definition would include the real brother and sister over and above the mother-father of the first degree relation.
- 3) As per the definition revised by the Hon'ble Apex Court, interpretation of clause 3 thereof as not made limited but if made in a broad perspective, then, it is clear that the person who wanted to consider such student as ward (Palya), then, he be considered to be proper subject to compliance of the following conditions:
 - a) He should be the nearest relation.
 - b) In the definition of the nearest relation, committee has considered following relative having blood relations.
 - Real brother and sister of father
 i.e. real uncle and real aunt.
 - ii) Real brother and sister of mother i.e. real maternal uncle and maternal aunt.
 - iii) Father and mother of father i.e. grand father and grand mother.
 - iv) Father and mother of mother i.e.
 maternal grand father and
 maternal grand mother.
 - v) First degree-paternal and maternal cousins.
 - vi) Such person should be NRI.
 - c) Such persons should ordinarily be residing abroad.
- d) Such person should have looked after such student as the guardian of the student and evidence to that effect

must have been produced before the committee by such person.

 e) There should be affidavit with aforesaid fact.

The Samiti directs the AMUPMDC and the Institute/Colleges to follow the above guidelines strictly while granting the admissions in NRI quota in respect of the First Year Health Science course for the academic year 2007-2008 and onwards."

After reproducing the said guidelines, the Division Bench of the High Court of Madhya Pradesh has held as under:-

"In view of the aforesaid, we are inclined to think that the term 'ward' has been given a broader meaning in Ruchin Bharat Patel (supra). We have reproduced the guidelines of Mumbai Committee to show that they are in consonance with the guidelines set forth by Ruchin Bharat Patel (Supra). Nothing has been placed on record to show that NRIs have acted in a mala fide manner.

Regard being had to the amplified meaning of the term 'ward' and in the absence of any mala fide and further on the foundation that the merit has not been completely given a go-bye, we are inclined to quash the decision of the Committee and hold that the admission of the petitioners under the NRI quota are valid and the petitioners are entitled to prosecute their studies under the said College."

On being asked, Mr. P.S. Narasimha, learned Additional Solicitor General has submitted that this Court may think of making any kind of interim arrangement subject to final adjudication of the controversy so that the same does not arise in future.

As presently advised, the principles set out in <u>Anshul Tomar</u> (supra), shall be followed this year for the purpose of filling up of 15% NRI quota. Be it clarified, the

NRI quota shall include Overseas Citizens of India (OCI) and Persons of Indian Origin (PIO). The counseling shall be held and finalised by 31st August, 2017, in respect of this quota and, if for some reason or other, the counseling is not concluded by that date, the same shall be completed by 4th September, 2017. It needs no special emphasis to state that the present order is only applicable to the deemed universities and no other category of institution.

Let the matter be set out for final disposal on $23^{\rm rd}$ November, 2017.
