Instructions for Candidates appearing for interview

- (i) Candidates appearing for interview must submit a copy of their research proposal at the time of Interview in form of Hard Copy and Soft copy.
- (ii) Please bring a valid ID proof (such as driving License, Aadhar Card, PAN card, etc.) that has your photograph at the time of interview.
- (iii) The final selection of Candidates is based on eligibility, interview, and availability of seats; consent of the supervisor and in accordance with the University rules.
- (iv) The admission of selected candidates is subject to fulfilment of the eligibility conditions and verification of her/his documents after declaration of result of the interview, availability of seats; consent of the supervisor and in accordance with the University rules.
- (v) All other relevant rules and regulation of University on this matter are applicable.
- (vi) The applicants must bring the following documents at the time of interview. Candidates must also submit a hard copy of the following photocopies of documents in the office of the Faculty:
 - All degrees, mark sheets, certificates, etc. for essential eligibility condition (in original and a self-attested Photocopy)
 - Proof of the claim of the benefit under any category- original certificates.
 - No objection Certificate from the employees (if relevant)
 - Caste certificate. OBC caste should be as per central list and a certificate of non creamy layer issued on or after 01.04.2023.
 - Any other relevant documents.

(vii) Please note the following IMPORTANT points:

As per the Point no. 18,19,20,21 under the IMPORTANT POINTS of University of Delhi, Bulletin of Information for Admission to Ph.D. Programme 2023-24 the candidates must check the eligibility conditions for registration to Ph.D. Programme.

Kindly note Point no 20 and 21 as under -

'if at any stage, documents submitted by the candidate relating to the admission are found to be fake/ non-genuine and/ or fabricated or in any other manner defective, the said candidate will not be given admission and if already admitted, admission will be cancelled without any prior notice in this regard. If the same is found after completing the Program, his/her degree will be revoked and appropriate legal action will be taken against such candidate'.

'A candidate's participation in the admission process will be provisional. If, at any stage, it is found that eligibility requirements are not fulfilled, the admission, if granted, shall be cancelled ipso facto and appropriate legal action will be taken against such candidate'.

Merely appearing in interview does not guarantee one's eligibility and/or claim to admission to Ph.D. Programme in Education.

- Please ensure your eligibility and bring all the relevant documents in original for verification.

If any candidate is found ineligible during the verification of documents, he/she would not be allowed to appear in the Interview.
