- 1. The candidates who are allotted seat in any Institute affiliated to University of Delhi **Super- Speciality (D.M/M.Ch) courses** are required to register themselves online in the Faculty website <a href="https://www.fmsc.ac.in">www.fmsc.ac.in</a> by paying specific fee as mentioned in Bulletin of Information (BOI)-2017 and uploading the documents as per BOI-2017.
- 2. The candidates shall report to the allotted College/Institution alongwith printout of Online Registration Form of Faculty of Medical Sciences and the following Certificates in Original alongwith two sets of self-attested photocopies for verification and for completing the admission formalities as specified by the concerned College/Institutes:-
  - (i) Registration form of Faculty of Medical Sciences, University of Delhi for (Super-Speciality (D.M/M.Ch) courses.
  - (ii) Allotment letter Issued by Medical Counseling Committee (MCC).
  - (iii) NEET-UG-2017 Admit Card.
  - (iv) NEET-UG-2017 Score Card.
  - (v) High School/Higher Secondary Certificate for verification of date of birth.
  - (vi) MBBS Degree.
  - (vii) Detailed marks certificate of qualifying examinations: I, II & Final Professional examination of MBBS.
  - (viii) Compulsory rotating internship certificate
  - (ix) Registration Certificate from Delhi Medical Council/State Medical Council/Medical Council of India
  - (x) MD/MS Degree/DNB Certificate.
  - (xi) MD/MS /DNB Examination attempt certificate.
  - (xii) Proof of writing thesis in case of candidate has passed DNB Course.

  The candidate shall:-
- (i) Login again with their existing login ID and Password.
- (ii) Submit details of the fresh allotment during 2<sup>nd</sup> round of Medical Counseling Committee (MCC) in the prescribed columns.
- (iii) Upload the copy of allotment letter issued in 2<sup>nd</sup> round.
- (iv) Need not to pay any fees.
- (v) Shall take the printout of the 2<sup>nd</sup> round admission slip.
