Note :

1. In case, there is no eligible candidate under OBC category, then vacant seat under OBC will be converted to UR category.
2. In case, there is no eligible candidate under SC category, then vacant seat under SC will be converted to ST category.

(A) **Seat allotment in Stray vacancy round of Counselling:** There will be seat allotment in the Stray vacancy round of counselling strictly according to merit/marks of NEET UG 2019.

Clause 6 (c) of Bulletin of Information 2019 states "The admission would be made strictly on merit on the basis of percentile of the eligible candidates in each category, determined by rank/ marks obtained in the NEET-UG -2019."

(B) **Eligibility for Stray vacancy round of counselling and tentative vacancy position:** List of eligible candidates which was provided by Medical Counseling Committee, Ministry of Health & Family Welfare, Government of India for Stray vacancy round of counselling and tentative vacancy position for Stray vacancy round of counselling is available on faculty website www.fmsc.ac.in. In this regard, candidates are advised to check regularly website of Medical Counseling Committee, Ministry of Health & Family Welfare, Government of India (www.mcc.nic.in) and website of Faculty of Medical Sciences www.fmsc.ac.in.

Eligibility Conditions/Requirement for admission to BDS Courses under 85% Delhi quota : Please see Bulletin of Information 2019 which is available on the website of the Faculty of Medical Sciences www.fmsc.ac.in

(C) **Entrance Examination:** In order to be eligible for admission to BDS courses for a particular academic year, it shall be necessary for a candidate to qualify the NEET-2019 exam and to obtain minimum of marks 50th percentile in National Eligibility Cum Entrance Test

(NEET2019) conducted by NTA for admission to MBBS/BDS courses held for the academic year-2019. However, in respect of candidates belonging to Scheduled caste (SC), Scheduled tri be(ST), Other backward classes (OBC), the minimum marks shall be at 40th percentile. In respect of candidates with benchmark disabilities specified under Rights of Persons with Disabilities Act, 2016 the minimum marks shall be at 45th percentile for UR-PwD and 40th percentile for SC- PwD, ST- PwD & OBC- PwD candidates.

The applicant may see notice F.U-11011/20/2019/MEC dated 12.09.2019 of office of ADG (ME), Directorate General of Health Services regarding revised qualifying criteria.

The candidates who have not qualified the NEET-UG-2019 Examination conducted by NTA are not eligible

- (D) Medical fitness: The candidate should be medically fit for the course.
- (E) A candidate who has been admitted in MBBS or BDS Courses earlier but has failed to pass the First Professional MBBS or First year BDS Examination will not be considered eligible for admission.
- (F) **Fee to be paid online after allotment of seat: Only those candidates who are allotted seats** in colleges affiliated to University of Delhi, after successful allotment of seats by the University of Delhi are required to **register themselves for admission online at Faculty of Medical Sciences, University of Delhi website www.fmssc.ac.in** They are required to complete the Registration by uploading their documents, photograph, signatures and the online payment of registration Fee.
- (G) **Original Documents with two set of Self attested Photocopies to carry:** As per page 14 of Bulletin of Information, Candidates appearing in last round/mopup round of counseling and offered admission in such Last Round candidate **must carry their original certificates in person** and they will have **No Right to surrender** their seats once accepted and **No extension of time for joining** will be granted.

The candidates are required to bring **following documents in Original as well as two sets of photocopies (self attested):-**

- (i) Passport size photograph of the applicant
- (ii) NEET-UG-2019 Admit Card
- (iii) NEET-UG-2019 Score Card
- (iv) Aadhar Card
- (v) Matriculation Certificate for verification of date of birth
- (vi) 11th and 10+2 Marksheet
- (vii) 10+2 Certificate
- (viii) Certificate from the Principal of the School on prescribed proforma available at faculty website: www.fmssc.ac.in stating that (i) the school is situated within National Capital Territory of Delhi, (ii) the school is recognized by the CBSE/Council for the Indian School Certificate/ Jamia Milia Islamia/Patrachar Vidyalaya/National Institute of Open Schooling(NIOS), (iii) the school is conducting regular classes, (except NIOS/Patracharya Vidyalaya) (iv) the applicant has attended regular classes in the school for class (standard) 11th & 12th (except NIOS/Patrachar Vidyalaya)

- (ix) The Candidates who have passed qualifying examination from Patrachar Vidyalaya or National Institute of Open Schooling will be eligible for admission in MBBS/BDS courses under 85% Delhi Quota provided their study center and the examination Center were within the National Capital Territory of Delhi (NCTD) and they must submit a certificate from the controlling authority of Patrachar Vidyalaya/NIOS in this regard
- (x) Character Certificate in Performa as prescribed by CBSE, issued by the Principal of the school last attended or any Gazetted Officer
- (xi) Scheduled Caste/ Scheduled Tribe certificate, if applicable
- (xii) Person with Disability (PwD) certificate, if applicable
- (xiii) Entitlement Certificate for C.W. category if applicable
- (xiv) OBC Certificate if applicable
- (xv) **Non-Creamy layer certificate shall be for the financial year 2019-2020, issued after 31st March, 2019 and OBC caste certificate as per the Central list for OBC's**
- (xvi) Overseas Citizens of India (OCI) card, if applicable
- (H) Last Date of Joining of Candidates:** The last date upto which the students can be joined in BDS course in 15th September, 2019 as per Time Schedule for completion of admission process for first BDS Course for the academic session 2019-20 as prescribed in "Dental council of India (Establishment of New Dental Colleges, Opening of New or Higher Course of study or Training and Increase of Admission Capacity in Dental Colleges) (13th Amendment) Regulation, 2018". Therefore, after successful allotment of seat, the candidate is advised to report to concerned college immediately. In no case, the extension of the joining time will be considered.
- (I) All admissions are provisional.**
