Admission Notification-MBBS/BDS Courses, Session 2015-2016 under 85% DU Quota

- In continuation of the admission notification no. FMDS/086/002/MBBS-BDS/Advt./2014/2043 dated 05/12/2014, it is notified for all concerned that the Bulletin of Information alongwith Application Form for admission to MBBS/BDS Courses under 85% DU Quota for the Session 2015-2016 can be obtained from the office of the Joint Registrar, Faculty of Medical Sciences, 6th Floor, VPCI Building, University of Delhi, Delhi 110007 from 11th May, 2015.
- 2. As already notified, on 05/12/2014, the University of Delhi, Faculty of Medical Sciences will not conduct a separate entrance examination for admission to MBBS/BDS courses under 85% DU quota for the session 2015-2016. Instead admission to MBBS/BDS Courses for all categories under 85% DU quota will be made on the basis of marks/merit obtained by the eligible candidates in the All India Pre-Medical/Pre-Dental Entrance Test (AIPMT)-2015 to be conducted by the CBSE.
- 3. The Bulletin of Information for admission to MBBS/BDS Courses under 85% Quota for the Session 2015-2016 based on the marks/merit of AIPMT-2015 will be available from 11.05.2015 (Monday) to 12.06.2015 (Friday) on all working days between 09:30 A.M. to 05:00 P.M. against a Bank Draft/Banker's cheque of Rs. 750/- (Rupees Seven Hundred Fifty only) for General/OBC category and Rs.550/- (Rupees Five Hundred Fifty only) for SC/ST/PWD. The Bank draft/Banker's cheque should be in favour of the 'Registrar, University of Delhi, payable at Delhi The BOI alongwith application form can be obtained from the office of the Joint Registrar, Faculty of Medical Sciences, 6th Floor, V.P. Chest Institute Building, University of Delhi, Delhi-110007.
- 4. The Bulletin of Information alongwith Application Form can also be download from the Faculty website: www.fmsc.ac.in or University of Delhi website <a href="www.du.ac.in and the same may be submitted to the Joint Registrar, Faculty of Medical Sciences, 6th Floor, VPCI Building alongwith required fee given at 3 above on or before 12.06.2015. The application form received after 12.06.2015 will not be accepted. The Faculty of Medical Sciences will not be responsible for delay/loss in transit of submission of application form.
- 5. Money in cash will not be accepted in any case for supply of Bulletin of Information
- 6. The concerned candidates are requested to kindly go through the Bulletin of Information before filling the application form.
- 7. Educational Qualification for admission to MBBS/BDS course under 85% DU Quota: Indian Nationals/Overseas citizens of India, who have passed 12th class examination under 10+2 system conducted by the C.B.S.E/ Council of the Indian School Certificate Examination/Jamia Milia Islamia, New Delhi with required subjects i.e. Physics, Chemistry, Biology/Bio-technology and English from the recognized schools conducting regular classes situated within the National Capital Territory of Delhi only, will be eligible for admission. The candidate must have studied 11th and 12th classes regularly from a recognized school within the National Capital Territory of Delhi. Further the candidate must have passed in the subjects of Physics, Chemistry, Biology/ Biotechnology and English separately and must have obtained a minimum of 50% marks (40% marks in case of SC/ST/OBC category candidates) taken together in Physics, Chemistry and Biology/Biotechnology".

In respect of candidates with locomotory disability of lower limbs, the minimum of 45% marks for Gen-PWD and 40% marks for SC- PWD /ST- PWD /OBC- PWD are required. Provided that a candidate who has appeared in the qualifying examination the result of which has not been declared, he may be provisionally permitted to take up the competitive entrance examination and in case of selection for admission to the MBBS/BDS Course, he shall not be admitted to that course until he fulfils the eligibility criteria.

- B. Eligible Female candidates from outside Delhi belonging to SC/ST/CW category who have passed the qualifying examination from Indian Universities/ Boards or Foreign Universities/Boards are eligible for admission to Lady Harding Medical College only against the seats reserved for these categories, subject to their fulfilling the prescribed conditions.
 - Note: (a) Merit list of SC, ST, CW categories of NCT of Delhi (who have passed qualifying examination from Delhi) shall be operated first for allotment of MBBS seats strictly accordingly to merit in terms of clause 2 (b) (i) of BOI-2015-2016.
 - (b) In case some seats remain unfilled after operating the merit list of SC, ST, CW categories of NCT Delhi, the same will be filled up by operating the merit list of the candidates who have passed qualifying examination from outside NCT Delhi in term of clause 2(b) (ii).
