**NOTIFICATION**

**Admission to MBBS course under 85% DU quota CW category,**  
**Session 2016-2017.**

In pursuance of the orders of the Hon'ble High Court of Delhi in cases of (i) Ananya MS & ORS Vs. Union of India & Ors (ii) Amrit Samra & Ors Vs. University of Delhi & Ors, the following changes in Priority II and Priority IV in CW category are carried out with immediate effect :-

- (i) Priority II: Disabled in action and Boarded out from service with disability attributed to military service.
- (ii) Priority IV: Disabled in service and Boarded out with disability attributable to military.

It is notified that the Counselling of CW (Delhi) General and OBC candidates under 85% DU quota will be held on **Sunday, the 25<sup>th</sup> September, 2016 at 09:00 a.m. onwards** in the Conference Centre, opposite Department of Botany, University of Delhi (North Campus), Delhi-110007. **Note:-**

1. **CW (outside Delhi) candidates are not required** to attend the Counselling as above in terms of Clause 2(b) (ii) of Bulletin of Information-2016.
2. **Further, the extended 2<sup>nd</sup> round of Counselling** will be held on **Thursday, the 29<sup>th</sup> September, 2016 at 02:30 p.m. onwards** in the Conference Centre, opposite Department of Botany, University of Delhi (North Campus), Delhi-110007.
3. Only wards of defence personnel in Priority I to V, as mentioned in Bulletin of Information – 2016, Clause - 3 E, are eligible to attend the Counselling. Wards of serving personnel (other than these covered under Priority V) are not eligible (**Reference: Ministry of Defence (KSB)-<http://www.ksb.gov.in>**).
4. All cases of disability in respect of defence personnel under Priority -II and Priority-IV, which are due to reasons aggravated by military service (**not attributable**) are not eligible (**Reference: Ministry of Defence (KSB)-<http://www.ksb.gov.in>**).
5. All the CW category candidates are required to submit the prescribed certificates in support of claimed priority such as certificate issued from Kendriya Sainik Board/ Office in-charge Record Office (Clause - 3 E of BOI -2016) along with supporting documents such as Medical board papers, pension pay order etc (**Reference: Ministry of Defence (KSB)-<http://www.ksb.gov.in>**).
6. If, it is found that at any stage that the applicant admitted on the basis of false information, provided by him/her, his/her admission shall be cancelled without any notice.
