INSTRUCTIONS FOR THE CANDIDATES ADMITTED IN MBBS AND BDS COURSES UNDER 15% ALL INDIA QUOTA (AIQ):-

The Candidates allotted seats under 15% All India Quota (AIQ) are advised to acquaint themselves thoroughly with the Bulletin of Information-2017 available at www.fmsc.ac.in.

A. 1ST ROUND OF COUNSELING 15% (AIQ):-

Reporting at the allotted Medical /Dental	16 th July to 22 nd July 2017 (up to 05.00
College against 1 st Round.	PM of 22 nd July, 2017)

- 1. The candidates who are allotted seat in any Institute affiliated to University of Delhi under 15% All India Quota(AIQ) are required to register themselves online for admission to Under Graduate Courses in the Faculty website www.fmsc.ac.in by paying specific fee as mentioned in Bulletin of Information (BOI)-2017 and uploading the documents as per para "Admission procedure" Clause- 1.2 (g) of BOI-2017.
- No verification shall be carried out by the University prior to allotment of seat. Instead, the verification shall be done by the college at the time of reporting of students in the College/Institutions for admission.
- 3. In case candidates are found to have furnished false information or documents etc. or are found to have withheld or concealed any material information while registering their application, their candidature/admission will be cancelled and fee deposited by him/her shall be forfeited.
- 4. The candidates shall report to the allotted College/Institution alongwith printout of online Registration form of Faculty of Medical Sciences and the following Certificates in Original alongwith two sets of self-attested photocopies for verification and for completing the admission formalities as specified by the concerned College/Institutes
 - (i) Registration form of Faculty of Medical Sciences, University of Delhi for (15% All India Quota).
 - (ii) Allotment letter Issued by Medical Counseling Committee (MCC).
 - (iii) NEET-UG-2017 Admit Card.
 - (iv) NEET-UG-2017 Score Card.
 - (v) Aadhar Card.

- (vii) 10+2 Marksheet.
- (viii) 10+2 Certificate.
- (ix) Recent Character Certificate issued by the Principal of the school last attended or any Gazetted Officer.
- (x) Scheduled Caste/ Scheduled Tribe certificate as described in Section –B, clause 1Λ, Bulletin of Information (BOI)-2017, if applicable.
- (xi) Father's SC/ST Certificate, if applicable.
- (xii) Person with Disability (Pwd) Certificate, if applicable.

- (xiv) OBC caste certificate (Non-creamy) layer certificate of the current financial year (i.e. issued after 01/04/2017) as per the Central list for OBC's.
