### A. GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY & UNIVERSITY OF DELHI

This is in continuation to University's Notification No. GGSIPU/Admissions/BDS/2017/22998 dated 4.8.2017 on the above subject. Alongwith this notification, the University appended therewith the three lists viz. Candidates with Valid NEET UG Roll Number; Candidates with invalid NEET UG 2017 Roll Number, and; the Candidates who did not submit their NEET UG 2017 roll numbers. List after incorporating the representations received, are appended herewith. Final merit / eligibility shall be checked at the time of counselling.

- 1. The NEET qualified candidates who registered in GGSIPU (for admission in BDS in the Medical College of University of Delhi and Guru Gobind Singh Indraprastha University) and whose names appeared in the merit list displayed on 8.8.2017; shall report in person for Verification of Documents and Allotment of Seats, at the venue of counselling, on the date and time mentioned below as per their Category and Rank.
- 2. Since this is a Common Counselling for admission in BDS in the college of University of Delhi and Guru Gobind Singh Indraprastha University, any eligible student, in merit, and on the basis of admissibility of their certificates, shall opt a seat from among the colleges of GGSIPU and DU, all the students are advised to go through the various notices / Bulletin of Information / Admission Brochure of both the Universities and prepare their documents.
- 3. Admissions in BDS for Academic Session 2017-18 shall be carried out by Guru Gobind Singh Indraprastha University for the following Dental Colleges, during the Common Counselling:-

5. SEAT ALLOTMENT WILL STOP AS AND WHEN THE VACANCIES ARE FILLED UP. Important Notes

[Counselling for the seats reserved for any Category shall be stopped as and when the seats in such Category are filled up. A notification about such closure shall be displayed on the University website and at the Notice Boards of the University. Candidates / parents are requested to regularly visit the University website <a href="https://www.ipu.ac.in">www.ipu.ac.in</a> for updates.

#### B. GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY

6. <u>Clarification of Scheduled Caste Category Certificate</u>. It is seen that some SC category certificates issued by competent authority of NCT of Delhi has a clause stating that this certificate is issued on the basis of certificate of parent issued by competent authority of a State / UT other than NCT of Delhi.

The benefit of reservation shall also be extended to all candidates who hold SC certificates issued from GNCTD provided such caste is enlisted in the list of Scheduled Caste as specified in Presidential Order 1951 as amended from time to time in respect of Delhi subject to fulfillment of other conditions specified therein. Please refer to the Annexure A attached to this notification.

Such candidates whose certificate has been issued by competent authority in GNCTD but their castes do not fall in Delhi, as specified in the Presidential Order 1951 (Annexure A above) shall not be considered for admission.

- 7. <u>Clarification on Other Backward Class Certificates</u>. Same as above, a certificate issued by a competent authority of Delhi on the basis of caste certificates of his/her parents from another State, will be accepted for claiming seat in OBC category if and only if the caste is in the list of notified OBC list by Govt of NCT of Delhi for claiming benefit of Delhi Region. THE NON-CREAMY LAYER CERTIFICATE SHOULD BE ISSUED AFTER 1<sup>ST</sup> APRIL 2017.
- 8. <u>Seats reserved to Physically Handicapped Candidates</u>. As notified vide University's Notification with regard to 'acceptability /admissibility of Certificates produced by the candidates claiming seats reserved for PWD/PH Category; vide Notice No. GGSIPU/Admissions/2017/21659 dated 3.7.2017, it is informed that all the candidates who furnish PH/PWD certificates issued from any Government Hospital located in Delhi or Outside Delhi under the provisions of 'The Rights of Persons with Disabilities Act, 2016" shall be eligible for claiming reservation on Delhi or Outside Delhi seats (based on the location of their qualifying exam). For BDS, in this Common Counselling, the seats are to be allocated in respect of Delhi Region seats.
- 9. For admission in ESIC Dental College & Hospital, only the candidates who have studied 10+2 (11<sup>th</sup> and 12<sup>th</sup> class) in the recognized School in Delhi only and passed the qualifying examination from any School located in Delhi only shall be eligible for admissions.

#### C. UNIVERSITY OF DELHI

Candidates are requested to visit the FMSC, DU website and refer to the Bulletin of Information of FMSC for acceptability / admissibility of reserved category certificates, fees, surety bond conditions etc.

- 10. The reservation certificate should be in the name of the candidate seeking admission. The reservation certificate in the name either of parents (Father / Mother) is not identical is not acceptable.
- 11. Age. Candidate should not be less than 17 years as on 31st December 2017 for BDS programme. Upper age limit for Unreserved Category candidates is 25 years as on 01/08/2017. However, this shall be relaxed by a period of five years for the candidates of SC/ST/OBC category

## 12. <u>Documents required at the time of Counselling / Admissions</u>

All eligible candidates shall bring the following documents in original along with an attested or self attested copy of the each at the time of Counselling/Admission.

- i) NEET UG 2017 Admit Card
- ii) NEET UG 2017 Score Card
- iii) Copy of GGSIPU Registration Form
- iv) Four passport size photographs
- Demand Draft(s) of Requisite Fee in favour of Registrar, Guru Gobind Singh Indraprastha University payable at Delhi. Details are mentioned below. Write the name of the candidate, name of the programme on the back of Demand Draft (s).
- vi) Copy of Admission verification form (duly filled by candidate as per Appendix 4(B) given in Part B, Admission Brochure 2017-18.
- vii) Preference Sheet (duly filled by candidate as per Appendix 7 given in Part B, Admission Brochure 2017-18.

- viii) Matriculation/High School/Higher Secondary Certificate for verification of date of birth;
- ix) Marksheet of Class XII
- x) The candidates must bring proof of having passed 11<sup>th</sup> standard exam (under 10+2 scheme) from Delhi (i.e. Marksheet and/or format of passing 11<sup>th</sup> from the School located in Delhi; available as Annexure C (attached)
- xi) Character Certificate from the head of the Institution from where the qualifying examination was passed or from Gazetted Officer.
- xii) SC/ST/OBC Certificate, if applicable (Original and One Photocopy).
- xiii) Appendix 1, Part B, Admission Brochure 2017-18 alongwith the relevant entitled certificates, if admission is claimed in Defence Category.

For acceptability of reserved category certificates and other terms and conditions etc; with regard to University of Delhi, all the candidates are requested to please refer to the Information Bulletin of Faculty of Medical Sciences, University of Delhi.

13. <u>Authority Letter and Undertaking for Authorized Representative</u>. If any candidate is not able to appear in person for counselling for genuine reasons, he/she may authorize someone to attend the counselling on his/her behalf. But such request has to be made on the prescribed format, Annexure B. Such authorized person shall carry along all the requisite documents alogwith the demand draft.

#### 14. ELIGIBILITY CRITERIA FOR ADMISSION AND SELECTION PROCDEDURE:-

Refer to Chapter 2 "Eligibility Conditions and Admission Criteria" Part A of the Admission Brochure for the academic session 2017-18.

15. Fee to be paid at the time of Counselling

- (a) At the time of counselling / admission in the University, a candidate will mandatorily bring a demand draft of Rs.40,000/- (i.e. 39,000/- fee and Rs.1000/- Counselling Participation Fee) and a separate Demand Draft of Rs.1000/- (Non-Refundable Counselling Counselling Participation Fee) in the name of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. If any candidate opts for a seat in GGSIPU, he/she shall pay the DD of Rs.40,000/- and Rs.1000/-. If he opts a seat in DU, he/she shall pay the DD of Rs.1000/- only.
- (b) In the interest of the candidates it is advised to prepared DD of both the amounts, if they so desire, to get the seat in any of the college of both the Universities.

#### 16. DATE AND TIME FOR REPORTING IN THE ALLOTTED COLLEGE

All the candidates admitted in 1<sup>st</sup> Round of Counselling, shall report in the allotted college on the next day of admission.

#### 17. DATE OF WITHDRAWAL OF ADMISSION

The allotted candidates may withdraw their admission upto 4.00 PM on 16.8.2017. Such candidates shall visit the Admissions Branch, GGSIP University, Sector 16C, Dwarka, New Delhi alongwith their original admission slip alongwith the prescribed format (Appendix 8 – Form for Withdrawal of Admission – available in Part B, Admission Brochure 2017-18).

All the refund applications shall be processed in accordance with the Refund Policy 2017-18, notified by the University vide its Notification, No. GGSIPU/ Admissions/2017/19103 dated 1.3.2017. The same is available on University website <a href="https://www.ipu.ac.in">www.ipu.ac.in</a>

#### 18. UPGRADATION / CHANGE FEE

Any candidate, who opts a seats in 1<sup>st</sup> Round of Counselling, is eligible for upgradation / change of college during the process of 2<sup>nd</sup> Round of Counselling. However, he shall pay a fee of Rs.5000/- (five thousand only), in addition to the 'Fee to be paid at the time of counselling', if such case occurs. Also, any candidate, who does not opt a seat during the first counselling, shall be eligible for admission in second counselling as per his/her NEET merit.

Any candidate who had taken admission in 1<sup>st</sup> Round of Counselling and subsequently withdrawn, shall not be eligible for admission in 2<sup>nd</sup> Round of Counselling.

#### THE CONSTITUTION (SCHEDULED CASTES) I (UNION TERRITORIES)] ORDER 1951 €.0.32

In exercise of the powers conferred by clause (1) of article 341 of the Constitution of India, as amended by the Constitution (First Amendment) Act, 1951, the President is pleased to make the following Order, namely:-

- 1. This Order may be called the Constitution (Schoduled Castes) 2[(Union Territories)] Order, 1951.
- 2. Subject to the provisions of this Order, the castos, races or tribes or parts of, or groups within, castes or tribes, specified in <sup>3</sup>[Parts I to III] of the Schedule to this Order shall, in relation to the <sup>2</sup>[Union territories] to which those parts respectively relate, be deemed to be Scheduled Castos so far as regards members thereof resident in the localities specified in relation to them respectively in those Parts of that Schedule.
- [3. Notwithstanding anything contained in paragraph 2, no person who professes a religion different from the Hindu, [the Sikh or the Buddhist] religion shall be deemed to be a member of a Scheduled Caste.]
- [4. Any reference in this Order to a Union territory in Part I of the Schedule shall be construed as a reference to the territory constituted as a Union territory, as from the first day of November, 1956, any reference to a Union territory in Part II of the Schedule shall be construed as a reference to the territory constituted as a Union territory as from the first day of November, 1966 and any reference to a Union territory in Part III of the Schedule shall be construed as a reference to the territory constituted as a Union territory as from the day appointed under clause (b) of section 2 of the Gos. Damen and Diu Reorganisation Act, 1987.]
