Notification Regarding Common Counselling of BDS Programme vis-à-vis Details of candidates registered and Date of Display of Schedule for First Counselling of BDS

Common Counselling for admission in BDS programme in the Medical College of University of Delhi, New Delhi and the College affiliated with <u>Guru Gobind Singh Indraprastha University</u>, New Delhi

Appended herewith are the three lists, pertaining to the details of candidates, who have registered for admission in BDS programme. The details are as follows:-

- 1. List of Candidates with Valid NEET UG 2017 Roll Number
- 2. List of Candidates with invalid NEET UG 2017 Roll Number
- 3. List of Candidates who have not submitted their NEET UG 2017 Roll Number

It is informed that 15% seats under All India Quota (AIQ) are allotted directly by the Directorate General of Health Services, Gol based on the merit of NEET UG 2017. For rest of the 85% seats, Common Counselling for admission in BDS programme in the Medical College of University of Delhi, New Delhi and the College affiliated with Guru Gobind Singh Indraprastha University, New Delh shall be carried out by GGSIPU University.

To claim seat under BDS programme, during the aforesaid Common Counselling, for the Academic Session 2017-18, the candidate must have studied 11th and 12th classes regularly from a recognized school within National Capital Territory of Delhi.

However, there are some students in the above lists, who appear to have studied their 11th and 12th Classes from a School not located in National Capital Territory of Delhi, such students are not eligible for admission in BDS programme through this Common

Mare.

Counselling; being conducted by GGSIP University for admission in the medical college of Delhi University and the college affiliated with GGSIP University.

Although, the Common Counselling shall be carried out for admissions in BDS in the college of University of Delhi and affiliated college of GGSIP University, terms and conditions of admission would continue to be applied in accordance with existing statutory provisions of the two Universities. Hence, the candidates are requested to refer to the Admission Brochure / Bulletin of Information of the respective Universities.

During the Common Counselling, the admission in the following colleges shall be granted:-

- 1. Maulana Azad Institute of Dental Sciences
- 2. ESIC Dental College & Hospital

With regard to conduct of BDS programme in ESIC Dental College & Hospital; and for the information of candidates seeking admission in BDS, attached herewith is a Memorandum from Headquarters' Office, Employees State Insurance Corporation regarding 'Revision of (i) Tuition Fees and (ii) Duration of compulsory service under Bond in UG (MBBS/BDS) programmes.

All the stake holders are requested to see the lists annexed herewith. In case of any representation / discrepancy in the notified lists, the candidates are required to visit the University Admission Branch from 10.00 AM on 05.08.2017 (upto 4.00 PM) to 07.08.2017 (upto 4.00 PM) with their representation / request within this stipulated date positively.

In case of any correction to be carried out, (as pointed out by the candidate, during the stipulated period, as mentioned in the above para) in Date of Birth, spelling mistake in the name or in the name of parents or in the choice of category / region claimed for the purpose of availing reservation in the submitted online form, application has to be submitted in the physical form alongwith the fee of Rs.500/- in the Admissions Branch, GGSIPU from 10.00 AM on 05.08.2017 (upto 4.00 PM) to 07.08.2017 (upto 4.00 PM).

The Schedule of 1st Round of Common Counselling for BDS shall be displayed on 08.08.2017 and the counselling shall be carried out from 10.08.2017 onwards.

The undersigned is directed to refer to the captioned subject and to inform that ESI Corporation has accorded approval for revision in (i) Tuition Fee and (ii) Duration of compulsory service under Bond in UG (MBBS/BDS) and PG (MD/MS) courses in ESIC Medical Education Institutions at its 170th Meeting held on 15/12/2016, as under:

- 2. The tuition fee would be payable in two equal half yearly instalments for both, UG and PG courses. However, 'Wards of IPs' would continue to pay annual tuition fee of ₹ 24,000/- as a single instalment (yearly).
- 3. The Deans are to communicate the Fee structure and Bond conditions with copy of Bond document to the concerned Appropriate Authority for admissions to these courses under All India Quota and State Quota for the year 2017-18 and onwards. The concerned Affiliating University is also to be informed as per requirement. The revised Bond document for UG and PG courses is enclosed.

AND WHEREAS the Corporation have agreed to incur the expenses on condition that after successful completion of the course of study the bounden shall serve any of the institution, of the Corporation or of ESI Scheme of the State Government, as the case may be, for a period of three years anywhere in India and also subject to the terms and conditions hereinafter appearing and the bounden and the sureties have agreed to the same.

NOW the condition of the above written obligation is that in the event the Bounden discontinues the study or after completion of the MBBS/BDS Course of study to which he/she was selected, fails to serve the Corporation for period of three years, the Bounden and sureties shall forthwith pay to the Corporation on demand the total amount of Rs 10, 00,000 (Rupees Ten lakh only) with interest @ 15% towards failure fulfill the obligation. The bond is legally binding on the bounder and the sureties and upon the payment of such sum the above written obligation shall be void and of no effect otherwise this shall remain in full force and effect:

PROVIDED further that the bounden and the sureties do hereby agree that if the Bounden discontinues the study or after completion of the UG (MBBS/BDS) Course of study to which he/she was selected, fails to serve the Corporation for a period of three years, it may be construed as professional misconduct and the fact reported to the Medical/Dental Council of India or of the Medical Council of the State concerned for suitable action including cancellation of Registration by the Council:

PROVIDED further that the bounden and the sureties do hereby agree that all sums found due to the Corporation under or by virtue of this bond shall be recovered jointly and severally from them and their properties movable and immovable as if such dues were arrears of land revenue under the provisions of the Revenue Recovery Act for the time being in force or in such other manner as the Corporation may deem fit.

Provided further that it is not necessary for the Corporation to sue the bond holder before taking action on the surety, under this bond and the liabilities of the sureties is Co-extensive with that of the Bounden and shall not be affected by the Corporation giving time or any other indigence to the bounden or by the Corporation varying of the terms and conditions herein contained,
