**Common Counselling for admission in BDS programme in the Medical College of University of Delhi and the College affiliated with Guru Gobind Singh Indraprastha University, to be carried out by GGSIP University**

→ **ADMISSIONS WILL BE MADE ON "NEET ALL INDIA RANK" PURELY ON MERIT**

→ **The Candidates who did not register are not eligible for Counselling.**

→ **"NEET ALL INDIA RANK" shall be referred to as 'Rank' further in this schedule.**

**A. GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY & UNIVERSITY OF DELHI**

1. This is in continuation to University's Notification No. GGSIPU/Admissions/BDS/2017/22998 dated 4.8.2017 on the above subject. Alongwith this notification, the University appended therewith the three lists viz. Candidates with Valid NEET UG Roll Number; Candidates with invalid NEET UG 2017 Roll Number, and; the Candidates who did not submit their NEET UG 2017 roll numbers. List after incorporating the representations received within the stipulated dates was displayed on 8.8.2017.

2. This has also reference to the **Schedule of 1<sup>st</sup> Round of Counselling / Admission** for BDS, Notification No. F. No. IPU-7/Counselling/Admission/01/BDS/2017/23033 dated 8.8.2017 held on 10.8.17 and 11.8.17.

3. For terms and conditions, acceptability of reserved category certificates, Age, Documents required at the time of Counselling, Authority Letter and Undertaking for Authorized Representative, Certificate from the Principal of the School last attended etc, please refer to the Schedule of 1<sup>st</sup> Round of Common Counselling.

4. Tentative Seat Matrix for BDS is attached herewith. However, the final vacancy position may change at the time of counselling, and shall be displayed at the time of counselling.

5. If the seats of sub-categories (i.e. Defence and PWD/PH) remain vacant, then they shall first be reverted to the parent category. Thereafter, the conversion of SC, ST, OBC to General Category shall be done only during the 2<sup>nd</sup> counselling. While converting the seats in 2<sup>nd</sup> round, any unfilled seat reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to General Category shall be effected.

6. With regard to Conversion of seats in University of Delhi, Bulletin of Information of FMSC, DU may please be referred. It is reiterated here that, however, this is a Common Counselling, eligibility criteria and other terms and conditions of admission would continue to

be applied in accordance with the provisions of the two Universities. So, the candidates are requested to refer to the Admission Brochure / Bulletin of Information of both the Universities.

**SEAT ALLOTMENT WILL STOP AS AND WHEN THE VACANCIES ARE FILLED UP.**

7. All the candidates have been called to ensure that no seat remain vacant. However, the counselling shall stop as and when the seats are filled up.

8. Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories during 2<sup>nd</sup> round of counselling. **This is tentative vacancy position and may change. Final vacancy shall be displayed at the time of counselling.**

9. For acceptability of reserved category certificates and other terms and conditions etc; with regard to University of Delhi , all the candidates are requested to please refer to the Information Bulletin of Faculty of Medical Sciences, University of Delhi.

10. Fee to be paid at the time of Counselling

(a) At the time of counselling / admission in the University, a candidate will mandatorily bring a demand draft of Rs.40,000/- (i.e. 39,000/- fee and Rs.1000/- Counselling Participation Fee) and a separate Demand Draft of Rs.1000/- (Non-Refundable Counselling Counselling Participation Fee) in the name of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. If any candidate opts for a seat in GGSIPU, he/she shall pay the DD of Rs.40,000/-. If he/she opts a seat in DU, he/she shall pay the DD of Rs.1000/- only. **Balance fee is to be paid at the allotted college directly.**

(b) In the interest of the candidates it is advised to prepared DD of both the amounts, if they so desire, to get the seat in any of the college of both the Universities.



11. **DATE AND TIME FOR REPORTING IN THE ALLOTTED COLLEGE**

All the candidates admitted in 2<sup>nd</sup> Round of Counselling, shall report in the allotted college on the next day of admission.

12. **DATE OF WITHDRAWAL OF ADMISSION**

The allotted candidates may withdraw their admission upto 4.00 PM on 24.8.2017. Such candidates shall visit the Admissions Branch, GGSIP University, Sector 16C, Dwarka, New Delhi alongwith their original admission slip alongwith the prescribed format (Appendix 8 – Form for Withdrawal of Admission – available in Part B, Admission Brochure 2017-18).

All the refund applications shall be processed in accordance with the Refund Policy 2017-18, notified by the University vide its Notification, No. GGSIPU/ Admissions/2017/19103 dated 1.3.2017. The same is available on University website [www.ipu.ac.in](http://www.ipu.ac.in)

13. **UPGRADATION / CHANGE FEE**

Any candidate, who opted a seats in 1<sup>st</sup> Round of Counselling, is eligible for upgradation / change of college during the process of 2<sup>nd</sup> Round of Counselling. However, he shall pay a fee of Rs.5000/- (five thousand only), in addition to the 'Fee to be paid at the time of counselling', if such case occurs. Also, any candidate, who did not opt a seat during the first counselling, shall be eligible for admission in second counselling as per his/her NEET merit.

Any candidate who had taken admission in 1<sup>st</sup> Round of Counselling and subsequently withdrawn, shall not be eligible for admission in 2<sup>nd</sup> Round of Counselling.

14. **Bond at ESIC Dental College**

The University vide its Notification No. GGSIPU/Admissions/BDS/2017/22998 dated 4.8.2017 enclosed therewith a copy of Bond format, which, every students, shall be required to fill up who secure admission in ESIC Dental College. The candidates are requested to directly contact the ESIC Dental College authorities in case they do require any information in this regard.
