Speaking Order

Sub: Speaking Order in compliance of the order dated 30.10.2018 of the Hon'ble High Court of Delhi in writ petition No.1747/2018 titled Ms. Bushra Iffat & ANR vs University of Delhi & Ors

- Whereas, Hon'ble Hight Court in writ petition No.1747/2018 titled Ms. Bushra Iffat & ANR vs University of Delhi & Ors has directed the respondent to pass a Speaking Order upon the representation of the petitioner within five days and then inform the petitioner the decision not later than six days.
- 2. Whereas, the Faculty of Ayurvedic & Unani Medicine, University of Delhi published Bulletin of Information for admission to BAMS/BUMS Degree Courses and the Bulletin of Information (BOI) contained all the guidelines and processes and procedures for provisional admission BAMS/BUMS courses.
- 3. Whereas, the petitioner had registered under Faculty of Ayurvedic & Unani Medicine, University of Delhi under UR category for admission to BUMS course for the academic year 2018-19 under 85% Delhi Quota.
- Whereas, there were 60 number of total seats in BUMS course and out of 60,
 seats were earmarked for 85% Delhi Quota and 9 seats were earmarked for 15% All India Quota.
- 5. Whereas, the first round of counseling for allotment of seats to eligible candidates on the basis of merit was held on 17.10.2018 and 2nd round of counselling was held on 24.10.2018. Since, there were no eligible candidate under SC/ST category, the seat were left vacant due to non-availability of eligible candidates from SC/ST category.
- 6. Whereas, the petitioner vide her representation dated 02.11.2018 has requested to transfer 12 Delhi Quota vacant seats of SC/ST category to common/UR category, which could not be filled due to non-availability of eligible SC/ST category candidates.

- 7. Whereas, the directions of the Hon'ble High Court were placed in the meeting of the Joint Admission Committee of Faculty of Ayurvedic & Unani Medicine, University of Delhi, Delhi, which was held on 3rd November, 2018. It has been decided by the Joint Admission Committee, in the light of the direction of Hon'ble High Court that SC/ST vacant seats cannot be converted to common category/UR as per the guidelines mentioned in the Bulletin of Information.
- 8. Whereas, as per the guidelines issued by the University vide the Bulletin of Information, the reserved seats for SC and ST category will be filled up by interchanging among SC and ST (if necessary) [please refer Section D. Point 1, Sub-Clause A(i) at page 15 of BOI] Further, if the reserved SC/ST seats remained unfilled, the same shall be kept vacant [please refer Clause 1(A)(ii) of Section D at page No.15 of BOI].
- 9. Thus, in the light of the above rule position, the vacant SC/ST category seats cannot be converted to UR category, even if there are not eligible candidates under SC/ST category. Hence, the representation is disposed off accordingly.
- 10. The petitioner is informed accordingly.
