General Terms & Conditions of Counselling for Admission to BAMS/BUMS for the Academic Session 2019-2020 for 85% Delhi Quota Seats.

- 1. Only NEET 2019 qualified candidates are eligible to participate in the counselling.
- 2. The general eligibility criteria of admission shall be as per Bulletin of Information (BOI) 2019 for BAMS/BUMS available on the website of the Faculty.
- 3. All the eligible candidates are required to register online on link provided on the website of the Faculty to participate in the counselling in accordance to given time frame.
- 4. The personal appearance of the candidates before the Admission Committee during the counselling along-with all original certificates as mentioned in the Bulletin of Information BOI is mandatory.
- 5. If any candidate called to participate in respective round of counselling remains absent to participate in that round, he/she shall not be allowed to participate in subsequent rounds of counselling.
- 6. Any candidate who fails to deposit the original documents along with the fee during the given time frame, he/she will not be considered in subsequent round of counselling and his/her claim to admission shall be forfeited.
- 7. Candidate must attain age of 17 years as or before 31.12.2019.
- 8. If any discrepancy/false statement is found in the documents of the candidate at any stage, his/her admission shall be cancelled and legal action shall be taken as per University rules.
- 9. All the admission made shall be provisional in nature subject to verification of documents submitted by the candidate.
- 10. If any dispute/issues arise, the decision of the admission committee shall be final.
- 11. In case the candidate does not report for counselling at the given date and time, he/she shall not be allowed to participate in the counselling.
- 12. All the candidates belonging to PwD category are required to produce disability certificate strictly as per the format given in the Bulletin of Information (BOI) and website of the Faculty of Ayurveda & Unani/AYUSH admission Central Counselling Committee (AACCC).
- 13. The tentative counselling/admission schedule is available on the website and all candidates are requested to follow the schedule strictly.
- 14. Any change is schedule or dates of counselling shall be notified on the website of the Faculty.
- 15. All candidates are requested to regularly visit the website for updates.
- 16. All the candidates are advised to read the Bulletin of Information (BOI) 2019 for admission to BAMS/BUMS carefully before registration and reporting for counselling.
- 17. The Faculty of Ayurveda & Unani Medicine, University of Delhi will conduct the Counselling for 85% Delhi Quota Seats.
- 18. Any order of Hon'ble Supreme Court/High Court or any other Court/ University of Delhi Regulatory Authority/Ministry of AYUSH etc. shall be applicable at any stage during admissions.
- 19. All the candidates are advised to produce original certificate in respect of reservation, educational qualification etc. before the admission committee on the day of counselling.
