- In case eligible candidate belonging to SC/ST categories are not available, the vacant seats shall be interchanged among SC/ST categories as per the University rule.
- The candidates who fulfill eligibility criteria as per Section A, Clause (2) BOI (BAMS/BUMS/BHMS) will only be allowed to participate in the Stray Round Counselling.

85% Delhi Quota:

The educational qualification as per National Eligibility Cum Entrance Test (NEET) conducted by National Testing Agency (NTA). Further to become eligible for 85% Delhi Quota, the candidate must have passed 11th and 12th examination under 10+2 system conducted by, (CBSE)/Indian School certificate examination/Jamia Millia Islamia, New Delhi or any other equivalent examination recognized by the University of Delhi for admission to under graduate course from a recognized school situated within NCT of Delhi only.
