2.	Mahir-e- Tib (MD/MS– Unani)	(i) For 50% Delhi University Quota: The Candidates must have passed final Kamil-e-Tibb-o-Jarahat (BUMS) examination from the University of Delhi and must have completed satisfactorily one year compulsory rotating internship in a recognized Hospital as on or before 31.10.2020 and must have registration with the State Council Board of Ayurvedic & Unani Medicine/ CCIM. Ref. No. F.No. R-11011/02/2018-EP (1M-1) Part-I dated 21.09.2018

The candidates are required to carry with them the following original documents at the time of counselling:

- High School/Higher Secondary Certificate for verification of date of birth.
- BAMS/BUMS Degree as per requirement of the course.
- Marks certificate of qualifying examinations: I, II, III & Final Professional examination of BAMS/BUMS/ and year-wise detailed marks certificates of Master's Degree/Bachelor's Degree, as required course-wise.
- BAMS/BUMS Examination attempt certificate.
- Compulsory rotating internship certificate.
- Registration Certificate from State Council/Board of A&U Medicine/Board of Homoeopathic System/CCIM/CCH.
- Scheduled Caste/Scheduled Tribe/OBC certificate, if applicable.
- Person with Disability certificate as per the format given at Annexure-I, if applicable.
- No objection certificate issued by the employer.
- Admit Card of AIAPGET- 2020.
- Score card of AIAPGET-2020.
- Bond:** A bond worth Rs.10 lacs with two sureties should be submitted by the candidates at the time admission. The admission will not be valid unless and until the Bond is submitted by the candidates. The performa of Bond is available on website www.fmsc.ac.in
- A candidate who selects is allotted a seat in the Stray round counselling shall have no right to surrender the seat. If she/he does so, he/she shall be debarred from appearing in the subsequent Post Graduate Degree Courses till the duration of the course concerned is over.
