CIRCULAR

Subject: Procedure for submission of thesis of PG Students MD/MS Batch-2023.

All the colleges/Institute are requested to follow the following procedure/instruction for the submission of thesis in respect of MD/MS Course Batch-2023 for which the last date is **31.08.2025**.

- 1. The students are required to download the thesis submission form Batch-2023 from the following link of https://fmsc.ac.in/forms.htm
- 2. The <u>form is required to print back-to-back</u> and the students must mention their Enrolment Number already allotted to them. Those students, who have not allotted the Enrolment Number, are required to contact their Institute/College.
- 3. The students are required to deposit the fees of INR 15,000/- to the South Delhi Campus Online Mode (through UPI, Paytm or any other mode).
 - (i) Name- Director, UDSC-Maintenance A/c (other Charges)
 - (ii) Bank- State Bank of India
 - (iii) Branch Code- 8778
 - (iv) Bank A/C No. 42113431541
 - (v) IFSC Code-SBIN0008778

(The receipt of this payment will be scanned by the candidate and submitted to the College concerned)

4. The link for payment of late fee (if any) is https://fee.du.ac.in/index.php/site/login

The students are advised to submit their thesis along with the following documents to their College/Institution latest by 31.08.2025. Before submission of the thesis to the College concerned, the MD/MS students must ensure that all the pending dues is cleared on or before 31.08.2025.

- a) Checklist Batch-2023
- b) One hardcopy of the thesis
- c) One hardcopy of the protocol
- d) One copy of Annual Tuition Fee (i.e 2nd & 3rd year), late fee receipt (if any).
- e) One signed softcopy of thesis in Pen drive.

Further, the College/Institution will be required to submit the data of PG students related to thesis in the prescribed format (i.e. Annexure 8), duly compiled by the department concerned, in the separate Pen Drive in the Faculty of Medical Sciences. Also, the thesis submitted by the students (One Hardcopy and Softcopy) along with all enclosures will be required to submit by the next working day i.e. 01.09.2025 (Monday) of the last date of thesis submission.

Note: As per the Clause No. 10.1 of PG Ordinance-2024, Extension for thesis submission for MD/MS/ beyond last date i.e. 31.08.2025 may be granted to a maximum of one month i.e. 30.09.2025 with late submission fee of Rs. 1000/- per day (as per University Notification no. Exam1/Secrecy/2024-25/690 dated 19.02.2024).

The concerned students may be informed accordingly.

The above guidelines/instruction may be circulated among the concerned students for their reference and necessary action.
