Subject: Last date of submission of Annual Tuition Fee by the DM/M.Ch. students of Batch 2022 (2nd and 3rd year).

Sir/Madam,

The matter under reference is related to the Last date of submission of Annual Tuition Fee.

In this connection, your reference is invited to the Clause 16.5 of MD/MS/DIPLOMA/D.M./M.Ch. ORDINANCES-2024 related to the **Payment of Annual Tuition Fee by 2nd & 3rd year PG students (D.M./M.Ch.)** states that

*The tuition fee amounting to Rs. 25,900/- (Twenty five thousand nine hundred only) is required to be paid by Post-Graduate students for the 2nd year and 3rd year **WITHIN FIRST MONTH OF THE STARTING OF RESPECTIVE ACADEMIC SESSION (2nd & 3rd)**, as notified by the NMC, time to time. Thereafter, Rs. 1500/- per week fine will be charged as late fees. No claim shall be there on College/Faculty if a candidate fails to submit the University Fees on time.*

Note: All the concerned medical colleges/institutions are required to provide the details of the fee deposited by the students (Batch wise) along with copies of the receipts within one week of the last date of deposited of the annual fee to the office of the faculty in hardcopy and softcopy for verification and record.


Further, the BRS in its meeting held on **30.01.2024 Item No. 4.** has considered the matter regarding date of submission of annual tuition fee by 2nd year & 3rd year students of the Super Specialty (DM/M.Ch.) Batch 2023 and the committee recommended that the last date for depositing 2nd year and 3rd year Annual Tuition Fee for the Super Specialty (DM/M.Ch.) students be counted after completion of the One year from the date of start of session. Therefore, the respective students will be required to deposit the Annual Tuition fee in the First week of the first month of the beginning of 2nd and 3rd year of the course. Thereafter, Rs. 1500/- per week fine will be charged as late fee till the time students submit the fee. Partial amendment in the PG Ordinance is recommended accordingly.

In view of the above, you are requested to instruct the students concerned to submit their fee in time and if the students who have not paid their Annual Fee with in prescribed date, is advised to deposit the remaining amount of late fee immediately under intimation to the office of the Faculty.
