Subject: Last date of submission of Annual Tuition Fee by the MD/MS/MDS/ Diploma students of Batch 2023 (3rd Year) and Batch 2024 (2nd year).

Sir/Madam,

The matter under reference is related to the Last date of submission of Annual Tuition Fee.

In this connection, your reference is invited to the Clause 16.4 & 16.5 available in the PG Ordinance 2024 related to the payment of Annual Tuition fee by 2nd year and 3rd year by MD/MS/Diploma of students of Batch 2023 (3rd Year) and Batch 2024 (2nd year). The same are as follows:

16.4 Payment of Annual Tuition Fee by 2nd & 3rd year PG students (MD/MS/Post Diploma):

The tuition fee amounting to **Rs. 15,900/- (fifteen thousand nine hundred only)** is required to be paid by Post-Graduate students for the 2nd year and 3rd year WITHIN FIRST MONTH OF THE STARTING OF RESPECTIVE ACADEMIC SESSION (2nd & 3rd), as notified by the NMC, time to time. **Thereafter, Rs. 1000/- per week fine will be charged as late fees. No claim shall be there on College/Faculty if a candidate fails to submit the University Fees on time.**

Note:- All the concerned medical colleges/institutions are required to provide the details of the fee deposited by the students (Batch wise) along with copies of the receipts within one week of the last date of deposited of the annual fee to the office of the faculty in hardcopy and softcopy for verification and record.

The last date for submission of Annual Tuition Fee by the MD/MS/MDS/ Diploma students of Batch-2023 (3rd Year) and Batch-2024 (2nd year) are as follows:-

| Batch | Course | Last date of submission of Annual Tuition Fee |
|-----------------------------|-----------------------|---|
| 2023 (3 rd year) | MD/MS/MDS and Diploma | 05.09.2025 |
| 2024 (2 nd year) | MDS | 01.08.2025 |
| 2024 (2 nd year) | MD/MS/Diploma | 20.12.2025 |

In view of the above, you are requested to instruct the students to submit their fee timely. Further, who have not paid their Annual Fees within prescribed date, are advised to deposit the remaining amount of late fees immediately under intimation to the office of the respective college/ institution.

The office of the college/ institution concerned is advised to contact the office of the Faculty for updating the details of the dues before depositing the fees by the concerned students.
