Subject: Procedure for submission of thesis of PG Students MD/MS Batch-2021.

All the colleges/Institute are requested to follow the following procedure/instruction for the submission of thesis in respect of (MD/MS) of Batch 2021. for which the last date is extended up to 15.11.2024.

1. The students are advised to submitted thesis on following manner:-

a) One hard copy of thesis

b) One signed electronic/softcopy of thesis in Pen drive.

Note: Thesis is to be submitted at college/institution level by the last date of submission. The college/institute will be required to submit the collected thesis (one hard copy and softcopy) with all relevant documents by the next working day of the last date of thesis submission. The College/institution will be required to submit the data in the prescribed format related to thesis for all the PG's duly complied of each department in the separate pen drive for submission to the Office of the Faculty of Ayurveda & Unani Medicines.

Extension for thesis submission for MD/MS beyond last date may be granted to a maximum of one month with late submission fee of Rs. 1000/- per day (as per University Notification no. Exam1/Secrecy/2024-25/690 dated 19.02.2024). In case of such late submission, of thesis beyond one month the student shall not be allowed to appear in the final examination at the end of normal duration of the course. He/she may be allowed to appear in supplementary or subsequent examinations at least six months after submission of the thesis, subject to approval of thesis. No relaxation will be granted in this regard.

The last date for submission of thesis is extended up to 15.11.2024, as one-time measure, and with late fine of Rs.1000/- per day up to 30.11.2024.

2. In addition to, the following documents are required at the thesis submission by the students: -

(i) One hard copy of protocol

(ii) One copy of Annual tuition fee (2nd & 3rd year), late fee receipt (if any).

(iii) Thesis submission form printed back to back candidates are required to fill enrollment number allotted to them in thesis submission form. Those who have not allotted enrolment number are required to contact their Institute/College.

(iv) The candidates will deposit the required fees of INR 15,000/- to the South Delhi Campus online mode (through UPI, Paytm or any other mode).
