COUNSELLING FOR ADMISSION TO POSTGRADUATE (MD/MS-AYURVEDA AND UNANI) COURSES UNDER 50% DELHI UNIVERSITY QUOTA FOR THE ACADEMIC YEAR 2024-25 :

It is notified for all concerned that in pursuance to the letter no. NCISM/Examination/StateDME/2024 dated 08.01.2025 for further reduction of minimum qualifying percentile criteria of AIAPGET 2024 by FIVE (05) percentile for SC & ST category candidates for admission in Post Graduate courses of ASU for the AY 2024-25, fresh registration is being allowed only for SC & ST category candidates, who fulfill minimum qualifying percentile criteria, for participating in the Extended Stray Vacancy Round to utilize the remaining vacant 03 (Three) seats of SC category (01 seat in Dravyaguna Vigyana, 01 seat in Rasa Shastra evam Bhaishajya Kalpana & 01 seat in Swasthavritta in AIIA) under 50% DUQ, who have not registered at AACCC-PG portal yet, but are willing to participate in DU-AYUSH counselling 2024, may also participate in the counselling for admission as per the following schedule :

1.	Online Fresh registration for such candidates of 50% DU Quota who have not registered themselves so far on the AACCC-PG Portal for admission to PG(MD/MS-Ayurveda) in the Academic Year 2024-25.	09.01.2025 (Thursday) to 10.01.2025 (Friday) up to 4 p.m.
2.	Uploading of list of fresh registered applicants.	10.01.2025 (Friday) at 5 p.m.
3.	Publication of final lists as per merit of eligible candidates.	11.01.2025 (Saturday)
4.	Publication of Result for Ex. Stray Vacancy Round of Counselling (Category wise) as per merit on the basis of AIR.	11.01.2025 (Saturday) at 1 p.m.
5.	Downloading of 'Provisional allotment letter' and reporting at allotted Institute/College for admission by the candidate as per seat offered on the basis of merit (AIR) and availability of seat in the respective category in the Ex. Stray Vacancy Round of Counselling.*	11.01.2025 (Saturday) to 12.01.2025 (Sunday) up to 4 p.m.
