ADMISSION NOTIFICATION

In continuation of the Admission Notification No. FAUM/028/PG-Admission/2025/7406 dated 02.12.2025, all concerned are hereby informed that the Joint Admission Committees (JAC) has decided to conduct Stray Vacancy Round the Counselling for admission to PG (MD/MS – Ayurveda & Unani) Programs for the session 2025-26 as follows:

Tentative schedule for the admission process:

1.	To Participate in SVR round the candidates first to exit allotted seat by giving consent to their colleges in written as well in mail.	15.12.2025 to 16.12.2025 (Monday to Tuesday) (10 a.m. to 5 p.m.)
2.	Choice filling for Stray Vacancy Round of Counselling by this URL: (https://faumpgallot.uod.ac.in/SeatAllocation)	17.12.2025 (Wednesday)
3.	Display of merit list of eligible candidates for Stray Vacancy Round of Counselling.	18.12.2025 (Thursday) Reporting time 10.00 am to 4.00 pm
4.	Reporting at allotted Institute/ College for admission by the candidate offered seat in the Stray Vacancy Round of Counselling.	18.12.2025 to 19.12.2025 (Thursday to Friday) Reporting time 10.00 am to 4.00 pm

Note: -

- A) The candidates are advised to refer to the PG (MD/MS – Ayurveda & Unani) and (MD- Homeopathy) Programs available on the Faculty website <https://fmssc.du.ac.in/> and <https://admission.uod.ac.in/> for any information regarding admission process.
- B) a) Candidates registered and participated in the previous rounds (1st, 2nd and 3rd) but were not allotted a seat will be eligible to participate in the Stray Vacancy Rounds.
b) Candidates joined the R-1, 2 and 3 allotted seat and submitted willingness for up-gradation at the time of reporting.
c) No upgradation in Stray Vacancy Round.
d) The candidate who are willing to participate in Stray Vacancy Round may required to exit from allotted seat.
- C) The candidate fill the choice at the time of registration and who had not allotted any seats through Delhi University Counselling are eligible for Stray Vacancy round of counselling. He/she is required to fill fresh choice filling as per schedule and earlier choice at the time of registration may be treated as null and avoid.
- D) Section 12 of PG BOI 2025 Upgrade & Freeze states as follows:
- The upgrade option will not be available for the candidate who was allocated his/her first preference.
 - A candidate who has been admitted to an allocated seat and desires to continue with it should submit a 'Freeze' request through his/her dashboard through application to concern college. On selecting 'Freeze/Lock, such a candidate will never be allowed to opt for "Upgradation."
 - If an admitted candidate neither opts for Upgrade nor Freeze and remains inactive in that round, the admission taken by him/her will be retained and s(he) will not be considered for upgradation in any subsequent round/s.
 - Selecting an upgrade does not mean an assurance of a seat in the next / any subsequent allocation rounds.
 - To exit from already allotted course, the candidates should submit consent in the concerned college.
- E) The above schedule is tentative in nature and in case of any change, the same will be notified on the official website.
