Subject: Re-opening of CW portal for submission of documents for entitlement/concession for seeking admission under CW category (85% Delhi Quota) to various UG Courses (MBBS/BDS/BAMS/BUMS/BHMS) for subsequent Round (2<sup>nd</sup> Round onwards) of UG Couselling 2025 (for (MBBS/BDS) and for all rounds of UG Courses (BAMS/BUMS/BHMS).

It is hereby notified that in compliance with the directions of the Hon'ble High Court, the CW (Children/Widows of Armed Forces Personnel) portal of University of Delhi is being re-opened to facilitate the registration of the candidates who missed the deadline of 11.07.2025 but had already obtained Education Concessional Certificate (ECC) in the prescribed format under CW Category.

Accordingly, all such applicants (NEET qualified) seeking admission under the CW category to various Undergraduate Courses (MBBS/BDS/BAMS/BUMS/BHMS) under the 85% Delhi Quota for the Academic Session 2025–26 are requested to submit the relevant documents related to CW concession/entitlement through the following portal:

# The format of Educational Concession Certificate (ECC) certificate is given at Appendix - K

# Terms and conditions:

- (i) The entitlement of the applicants for their claim under CW Category shall be considered as per Priorities claimed by them on the basis of the ECC issued by the concerned issuing authorities in the prescribed format of the Faculty of Medical Sciences, University of Delhi only. In case, the documents uploaded by the applicant at the time of registration does not support the claimed Priority in the ECC then the applicant will be declared as 'Not Eligible'
- (ii) The applicant for admission to UG Courses (MBBS/BDS) under CW Category will be required to upload all the relevant documents in prescribed format and size which is in legible form at the time of submission of their application. Further, the applicant will not be allowed for addition any new document after final submission of their application on the CW Portal and there would be no further communication allowed in any case. No Change or additional documents will be accepted after the documents have been uploaded on the online CW portal.
  - (iii) The consolidated list of the registered candidates on the CW portal for entitlement under Delhi Quota (85%) shall be verified by the MCAC (UG) for their eligibility as per norms of the University of Delhi. The list of the candidates eligible for Delhi Quota (85%) shall be provided to the KSB, PMA Cell, MHA (for priority V (vii & x) and WARB, MHA (for the remaining Priorities Priority I to V only) alongwith the application forms and relevant documents for verification, as the case may be. The candidates who will not fulfill the eligibility criteria for Delhi Quota (85%) shall be excluded from the list with the remark "Outside Delhi candidate".
  - (iv) The authorities of KSB, PMA Cell, and WARB, MHA will be responsible for addressing any grievances or litigations arising from the verification of CW/ECC certificates submitted by candidates through University of Delhi. The University of Delhi will not be held responsible for such issues.
  - (v) The Issuing authority is responsible for the issuance of this certificate in accordance with the governing laws and regulations of the Ministry of Defence / Ministry of Home Affairs, as applicable.
  - (vi) In the event of any issue/claim/dispute before the court of law in the matter of Priority assigned, the issuing authority shall defend the case, in the court of law and the University of Delhi shall be indemnified for such issue/claim/dispute.
  - (vii) The provisional list of the eligible candidates for their entitlement under CW Category (Delhi Quota) duly verified by the KSB/MHA shall be forwarded to the MCC before the commencement of the Ist Round of councelling to conduct the counselling and to allot the seat on the basis of All India Rank, Category and Priority of the respective candidates for provisional admission subject to verification of the original documents by the concerned college at the time of reporting for admission by the selected candidate.

# 2. Prohibition and Punishment for Ragging: OrdinanceXVC:-

  - (a) involve physical assault or threat to use of physical force;
  - (b) violate the status, dignity and honor of womenstudents;
