It is notified for all concerned that the Admission to PG (MD/MS – Ayurveda & Unani) and (MD- Homeopathy) Programs for the session 2025-26 under 50% Delhi University Quota for the session 2025-26 in Faculty of Ayurveda & Unani Medicine and Homoeopathy Medicines, University of Delhi, will be undertaken on the basis of merit of AIAPGET-PG-2025-26.
2. Only, eligible candidates are required to register on online portal link <https://faumpg.uod.ac.in/index.php/site/index> at Faculty website <https://fmsc.du.ac.in/> and <https://admission.uod.ac.in/> to participate in the Counselling for admission to PG (MD/MS – Ayurveda & Unani) and (MD- Homeopathy) Programs.
3. The candidates under 50% All India Quota are also required to register themselves after allotment of seats from AACCC at the online portal link <https://faumpg.uod.ac.in/index.php/site/index>.
